Court of Appeals & Fourth Department Case Notes

Child Custody - Sua Sponte Modification To Sole Custody

Warren v Miller, 2015 NY Slip Op 07366 [4th Dept Oct. 9, 2015] Despite the fact that the only petition pending before the court was one to modify the existing visitation schedule, Family Court had jurisdiction to determine issue of custody sua sponte; the parties were adequately apprised that sole custody was at issue, as court twice informed them prior to hearing that sole custody would be at issue and specifically warned father he could lose custody if he failed to present evidence contradicting mother's testimony, additionally, father had sufficient opportunity to, and did, present testimony and evidence relevant to custody.

Child Custody - Default Order, Lack Of Proper Service

Kader v Kader, 2015 NY Slip Op 07384 [4th Dept Oct. 9, 2015] Petition to vacate default judgments for lack of jurisdiction should have been granted where the affidavit of service by "nail and mail" demonstrated that only three attempts at service, all on weekdays during normal business hours, had been made, and although a process server's affidavit of service ordinarily constitutes prima facie evidence of proper service, the affidavit submitted did not contain any averment whether the process server had made an attempt to effectuate service at the mother's actual dwelling place or usual place of abode, or whether he had made genuine inquiries to ascertain the mother's actual residence or place of employment.

Child Custody- Evidence, Admissibility Of Video

Blair v DiGregorio, 12015 NY Slip Op 07383 [4th Dept 10/9/15]

A video may be authenticated by a person other than the creator of the video where the testimony of a witness to the recorded events demonstrates that the videotape accurately represents the subject matter depicted.

Child Custody- Evidence, Expert Testimony Not Necessary

Procopio v Procopio, 16 NYS3d 879 [4th Dept., 10/2/15] Testimony of children's therapist was admissible in court proceeding in which it was determined that mother's visitation with children would be supervised, notwithstanding that she was not qualified as an expert; therapist was permitted to testify as a fact witness. In addition, the record supported the court's determination that it was in the children's best interest to prohibit mother from sending text messages to them.

Child Custody- Parental Alienation, Child's Wishes

Burns v Herrod, 2015 NY Slip Op 07351 [4th Dept 10/9/15]

Mother's numerous unfounded reports of alleged abuse of the children constitutes a concerted effort to interfere with the other parent's contact with the children, which is so inimical to the best interests of the children as to, per se, raise a strong probability that the interfering parent is unfit to act as custodial parent. Further, while the children's wishes are a necessary factor to consider, the court was, not required

to abide by the wishes of the children to the exclusion of other factors in the best interests analysis.

Child Custody - Relocation

Lapoint v Pelliciott, 130 AD3d 1453 [4th Dept., 7/2/15] Family court erred in designating mother as "parent of primary residence," thereby implicitly condoning mother's relocation to Florida with the parties' child; court made no explicit determination in custody proceeding that relocation was in the best interests of the child, and failed to make findings regarding relevant factors that were required to be considered in making such determination, as required by Matter of Tropea v. Tropea, 87 N.Y.2d 727.

In re Moredock, 130 AD3d 1472, 1473 [4th Dept., 7/2/15]

The Court agreed with the father that the lower court erred in failing to analyze this matter as one requiring a determination whether the relocation was in the best interests of the child after considering all relevant factors, as required by Matter of Tropea v. Tropea, 87 N.Y.2d



727. That determination was required "notwithstanding the fact that the [mother] had already relocated with [the child]". Nevertheless, the record was sufficient for the Fourth Department to make such determination, concluding that the mother demonstrated by a preponderance of the evidence that her relocation of the child was in the child's best interests.

Child Custody- Sufficient Change In Circumstances Demonstrated By Parent's Substance Abuse

Creek v Dietz, 16 NYS3d 888 [4th Dept., 10/2/15]

Father's use of illegal drugs was sufficient change in circumstances to warrant modification of child custody and visitation order to restrict father to supervised visitation, where father, who had long history of substance abuse problems, admitted that he had used illegal drugs only a few weeks before hearing on mother's petition, and demonstrated behavioral changes consistent with his behavior during prior periods of times in which he had been using illegal substances, such as missing visitation for extended periods of time.

Child Protective Proceedings - Defining Person Legally Responsible

In re Trenasia J., 25 NY3d 1001 [Ct. App. 5/5/15] Evidence in child protective proceeding was sufficient to establish that 11-year-old child's uncle through marriage was a person legally responsible for the child who could be named a respondent under Family Ct Act § 1012(g) and for the determination of derivative neglect after the uncle was alleged to have forcibly attempted to have sexual intercourse with the child. Evidence indicated that child had been staying at her uncle's home for a week prior to the incident and had visited the uncle's home eight or nine times, with four overnight visits during the prior year, that the uncle was the only adult present at the time of the incident, and that

The nature and length of contacts between an uncle and a child, the uncle's control over the child's environment, and the familial relationship between them, supported this determination.

Child Protective Proceedings - Standing To Appeal

In re Arkadian S., 130 AD3d 1457 [4th Dept., 7/2/15]

Father was not aggrieved party and therefore lacked standing to appeal order finding that father abused and derivatively neglected children, since he did not formally join in mother's motion to vacate order.

LOWE CENTER FOR JUSTICE DEDICATED ON OCTOBER 29















On Thursday, October 29, the George H. Lowe Center for Justice officially opened. The center brings three legal service providers under one roof: Legal Services of Central New York, Legal Aid Society of Mid-New York and the Volunteer Lawyers Project. The dedication honored the years of effort and advocacy by Judge Lowe to increase access to justice for all in Central New York.

Expanding free legal services for the indigent has always been one of Judge Lowe's top priorities. In the 1990s he began pursuing a "One Roof" concept to house all of the charitable legal services providers in greater Syracuse. This concept, which has materialized as the Center for Justice is well along the way to improve access to services for low income clients and create synergy between the organizations.

The event included tours of the Lowe Center and a dedication ceremony which included remarks by Mayor Stephanie Miner, Congressman John Katko, Michael Getnick, Assemblyman William Magnarelli, Judge James Tormey, and Judge George Lowe, as well as remarks by LSCNY and LASMNY board president Joanne Piersma and OnVLP board vice president Larry Bousquet.

VLP'S NEW PROGRAM SEEKS TO ADDRESS THE NEEDS OF THE HOMELESS: CALL FOR VOLUNTEERS

The Volunteer Lawyers Project is proud to announce their latest program, the Homeless Advocacy and Prevention (HAP) Program. The HAP Program will focus on addressing legal needs that often are barriers to rising out of homelessness, such as child support modification, divorce and employment issues, while at the same time providing general advice and referrals for other essentials of life such as access to health care and subsistence income. VLP is seeking volunteer lawyers for this new initiative – you do not need to have experience with the specific areas of law listed above, VLP will be providing trainings to support volunteers to this program. This program is building upon our already successful clinic at the Rescue Mission's Day Center.

Currently, spread across the six major shelters in the Syracuse area, there are 430 beds, 99% of which are being utilized. These shelters offer an opportunity to provide critical interventions that can be transformative in the lives of clients. The HAP program will establish talk-to-a-lawyer clinics at each of these local shelters, to be staffed by volunteer attorneys from our legal community. The clinics will be held 2-4 times each month, depending on the size and need of the shelter. Most of the clinics will operate for an hour or two during dinner hours, a time that is convenient for both clients and volunteers. The volunteer attorneys will be providing advice, counsel and brief assistance on a variety of civil legal issues, as well as referrals to other legal and social services where appropriate.

The first training for volunteers who are interested in helping at the Catholic Men's Shelter (formerly the Oxford Inn) will be on

November 19th at 5:15pm at the Volunteer Lawyers Project offices. If you are interested in attending this training or signing up to volunteer at any of our developing HAP Program locations, please contact Derek English, Esq. at the Volunteer Lawyers Project, denglish@onvlp.org or (315) 579-0177. Derek, a recent VLP hire with extensive experience in civil legal issues affecting low income clients, will be heading up this new initiative.

Homelessness doesn't just affect those who are homeless, but it affects society as a whole. Together, as attorneys, we can utilize our skills and knowledge to combat this problem and provide a better community for all!



The October 26, 2015 OCBA Paralegals Committee Luncheon was held on location at the Onondaga County Courthouse. The Honorable Michael L. Hanuszczak spoke to a rather large gathering about the different cases that are handled in Family Court. There were many new faces in the audience including several students from Bryant & Stratton College.



Judge Hanuszczak has served as a Family Court Judge in Onondaga County for twelve years and has served as Acting Supreme Court Justice in the Fifth Judicial District since 2004. He currently presides over the Family Treatment Court and previously presided over the Integrated Domestic Violence Court. Judge Hanuszczak received his undergraduate degree from Syracuse University's Maxwell



School and obtained his law degree from SUNY Buffalo Law School. He spent ten years in private practice and served for a number of years as a member of the Fourth Department's Attorney for the Child Panel. Judge Hanuszczak has an extensive public service background including serving as a member of the

Onondaga County Legislature, Central New York Regional Office Head in the New York State Attorney General's Office and Special Counsel to the Chair of the Workers' Compensation Board.
