I think it appropriate at this time to review the Mission of the OCBA, which you will find recited at the bottom of the first page of each and every issue of the Bar Reporter:


"To maintain the honor and dignity of the profession of law, To cultivate social discourse among its members, and To increase its significance in promoting the due administration of justice."

Passion breeds success in the case of OnVLP

■he attorneys who share their expertise with the Volunteer Lawyers Project received a heartfelt thank you from the agency's Executive Director Sally Fisher Curran, Esq.

Curran described durina 2nd Volunteer the June Appreciation Luncheon the extent to which she and her ever-growing staff are grateful for the pro bono services the lawyers provide.

"Each of you serves as an ambassador out in the

community for the pro bono work that is done here at Volunteer Lawyers Project," she said. "The work you do is more important than you can possibly imagine.

"We have some of the most outstanding volunteers, people who put in so much time throughout the year."

In 2016, 750 lawyers committed 5,103 hours to 10 VLP clinics or programs. These include:

- Legal Needs Survey
- Onondaga County Family Court Clinic
- **Eviction Defense**
- Elder Law & Disability
- **Unemployment Insurance**
- Community Economic Development
- Homeless Advocacy & Prevention
- Re-Entry, New Start Program
- Immigration Law Clinic
- Talk to a Lawyer Clinics
- Veterans Clinic
- **LGBT Legal Issues**

Based on 2015-16 statistics, and on its seeming neardaily development of new clinics and programs, VLP's rising trendline approaches off-the-chart status. Since 2013, shortly after it cleaved away from the Onondaga County Bar Association, VLP has realized a 106 percent increase in the number of low-income

residents receiving free legal

services.

An early and ardent fan of the legal services provider, NYS Assistant Attorney General and VLP Board member Christopher Wiles sums up its effective modus operandi.

"If you have a passion for what you're doing, you're going to be successful," he said.


The brainchild of the Hon. George H. Lowe, in response to the state's pressing for mandatory pro bono service, the agency emerged from an OCBA volunteer pro bono program in late 1990.

As Legal Services of Central New York and the Hiscock Legal Aid Society worked to meet the legal needs of the county's poor, Lowe entreated OCBA members to commit time to the new program. He opined the following in his September 1990 Bar Reporter President's Letter-

"If we do not significantly increase our voluntary efforts, I personally am convinced that mandatory pro bono will be imposed upon us, opening up a bureaucratic can of worms that will make the Office of Court Administration pale by comparison."

His concern was allayed when the nascent VLP

received a \$125,000 IOLA grant, plus an additional \$1,000 from the Onondaga County Bar Foundation. These monies meant the bar association could establish a paid staff to structure a volunteer pro bono program of OCBA members.

Anthony J. Gigliotti, Esq., principal counsel for the Attorney Grievance Committee, was hired in December 1990 to lead the then-newly named Volunteer Lawyers Project.

In his time with VLP, Gigliotti formed the Landlord/ Tenant Clinic, now helmed by Samantha Aguam, Esq. and Deb O'Shea, which operates weekday mornings and is considered a statewide model for programs like it.

VLP volunteers are from law firms, solo practitioners and even certified law students who represent as many as 1,000 of the 6,000 to 7,000 eviction cases annually litigated in Syracuse City Court.

"I learned from having spent a year on the bench in city court that having everyone represented makes the court system function better," Gigliotti said. "It's universally felt by judges who sit there that this has been an asset to the eviction process."

According to Aguam, 70 percent of the people VLP represents either avoid or

delay eviction and thereby evade homelessness.

"At the end of the day, our eviction defense program is a homelessness prevention program," she said.

Four of Syracuse's large law firms already prompt associates to volunteer their time providing pro bono services, but VLP needs even more help. Trained by VLP staffers, Landlord/Tenant Court volunteers who give one morning a month, or more, can net significant results.

A 10-year VLP volunteer, Neil J. Smith, Esq., a partner at Mackenzie Hughes, has seen those "shocking for a city this size" days in court when as many as 50 people *in one day* face losing their home.

"It's very satisfying to know that the bar here is really focused on pro bono. If they weren't there'd be a lot more for the government itself to pick up and handle," said Smith. "It's a positive sign about the strength of our community."

Attorneys of every experience level and background are needed and volunteering can be especially helpful for those lawyers in between jobs, said Aquam.

"You can really make an impact by donating a morning to help out in eviction court. You could help prevent four evictions or help defend four people in one morning," she said.

Aguam also supervises VLP's various Elder Law and Disability programming. The Surrogate's Court Clinic she oversees currently sustains a roster of 25 to 35 attorneys.

By virtue of being attorneys, we possess a skill set that is valuable to people in our community. Those skills can empower individuals and change lives. Our low-income residents need lawyers who speak plainly and clearly, and who are willing to give of their time and energy.

Volunteer Lawyers Project organizes an amazing group of volunteer attorneys. One thing about VLP that has impressed me over time is how easy they make it to volunteer. They handle the scheduling, training, and usually the intake. Attorneys, generally, just need to show up and use their talents to help people. It's never been easier to volunteer!

"It's very popular," she said. "But this program would not exist without their help."

Like the reach and grip of octopus tentacles, Gigliotti observed, poverty's influence is evident in cases ranging from eviction and domestic violence to instances of adult illiteracy and low health and wellness outcomes.

"There are so many things that have their origin in it," he said.

This trend is not lost on Curran and her staff who recognizes Syracuse's top position as an economic underperformer means more people cross VLP's threshold.

According to the Brookings Institute's Metro Monitor Dashboard 2017, Syracuse rates last in economic growth, 100th out of a list of 100 cities.

"We're the worst and we're at the top for concentrations of poverty so the idea was if we can help people from the low-income communities build a job themselves there's a lot of entrepreneurial spirit maybe we can help them succeed and get out of poverty," Curran said.

If the Landlord/Tenant Court Clinic combats homelessness then VLP's new Community Economic Development program strives to feed and foster a good business plan.

Open since March and led by Cheryl Jones, Esq., this program has more than 50 cases ready for input from lawyer-volunteers.

"Of which 25 urgently need an attorney," Curran said.

Despite the challenges of a low-income reality, these clients burn with a desire to change their circumstances and build a small business. All are workforce development program graduates referred to VLP to square up their new business's legal needs by, for example, CenterState CEO, who spends months helping them prepare a business plan, Jones said.

"First and foremost they have great ideas," she said. Jones pores over the plans, guiding the new enterprises through proper formation protocols and low-credit score remediation while also promoting her client's work in the community.

"The legal and business advice that these entrepreneurs are being provided will definitely prevent a majority of them from failing," Jones said.

"What I see is that these entrepreneurs, who are receiving the advice now, their businesses flourishing and them bringing us more clients and then us having a community with businesses that are successful."

Thus, more growth and innovation and opportunity and less, much less, poverty.

To help their neighbor by freely providing their time and expertise keeps lawyers returning to VLP.

Todd M. Long, an Onondaga County Law Department attorney, and recipient of the 2017 New York State

Bar Association President's Pro Bono Service Award, has been a VLP Homeless Advocacy & Prevention Program volunteer since he began practicing law. Not implying that being of low-income equals a chaotic state, or that being a lawyer is a placid perch, Long paraphrases a favorite quote to describe why he volunteers.

"The definition of mercy is to enter into someone else's chaos."

Today, VLP is funded by a variety of grants and is expanding its opportunities for lawyers to apply their skills for the benefit of Onondaga County citizens.

Local Teachers Learn of OCBA's Lawyers in the Classroom Program

he Hon. James P. Murphy, met with educators from nine area school districts
June 8th to understand how OCBA members can bring their legal knowledge to benefit area high school students.

The judge explained the need he witnesses in his court for this kind of corollary instruction by legal professionals, if for no other reason than to provide a basic civics lesson.

In a letter to the schools, Murphy wrote: "The bar association would assign at least one volunteer lawyer and perhaps a law student to each participating high school who would come to your school and speak to students throughout the school year on any topic involving the courts, public service, civil or criminal law, fundamental principles of justice and/or any topics that your teachers feel would be beneficial."

For example, he said, lawyers boast a keen understanding of The Constitution and could augment Social Studies or History classes covering sections on government or the political system. And attorneys with contracts expertise might fortify a business teacher's lesson plan by speaking on standard agreements such as leases and business structure.

One Social Studies teacher agreed heartily and briefly touched upon the "crisis level" Civic Achievement Gap students fall into until their senior year when they often take one government/economics class. He called this a "major marginalization of the subject area" created in the wake of Social Studies not being tested at the state level.

The teachers also brainstormed ideas such as: Lawyers as guest speakers during Superintendent Days/Professional Development Days – in essence teaching the teachers. SUCOL 3L Christopher Clark Runner-Up at National Mock Trial Competition



hristopher Clark 3L was the runner-up in the 2017 Top Gun National Mock Trial Competition. Clark won three rounds of head-to-head competition against students representing 15 other law schools from across the country. Nick Dellefave 3L assisted Clark during the competition.

"Congratulations to Christopher for this amazing accomplishment," said Kathleen O'Connor, Faculty Director of the Moot Court Honor Society and Advocacy. "Top Gun is a very difficult competition and to have advanced to the finals speaks well of his capabilities and skills as an advocate in the courtroom."

Top Gun is an innovative, invitation-only mock trial tournament where the single best advocates from some of the top 16 trial advocacy schools go head-

to-head for the honor of Top Gun. The winner earns a \$10,000 prize.

Unlike other mock trial competitions, participants do not receive the case file until they arrive at Baylor Law School, a mere 24 hours before the first round of trials begin. Preparation includes reviewing depositions, records, and photographs, and taking a trip to the actual places where events in the case supposedly occurred. Shortly before each round, competitors are assigned a witness or witnesses who may be used at their discretion during the round. The jurors for each round are distinguished trial lawyers and judges.
