# FROM THE PRESIDENT

For many of us, the end of the year is a particularly crazy time. I hope you all enjoyed a bit of a respite and the Thanksgiving holiday with your friends and family.

As you may know, as an Officer of the County Bar Association, I am a member of the New York State Bar Association House of Delegates, which is the policy making branch of the organization. I attended the last meeting of the House in early November in Albany and the House unanimously adopted a Report concerning equality for women attorneys in litigation and ADR roles.

The Report is entitled "If Not Now, When? Achieving Equality for Women Attorneys in the Courtroom and in ADR." It can be viewed at <u>www.nysba.org/</u> <u>WomensTaskForceReport/</u> and I encourage you to read it. More than 2,800 state and federal judges and mediators/arbitrators were surveyed. "The focus of the first survey was to track the participation of women as lead counsel and trial attorneys in civil and criminal litigation." Despite the fact that women and men have been graduating at an equal rate for more than a decade, the results of the survey "found continued disparity and gender imbalance in the courtroom."

Unfortunately, the survey conclusion was probably not surprising, however, the degree of the disparity is startling. For example:



• Female attorneys represented just 25.2% of the attorneys appearing in commercial and criminal cases in courtrooms across New York.

• Female attorneys accounted for 24.9% of lead counsel roles and 27.6% of additional counsel roles.

• The most striking disparity in women's participation appeared in complex commercial cases: women's representation as lead counsel shrank from 31.6% in one-party cases to 26.4% in two-party cases to 24.8% in three-to-four-party cases and to 19.5% in cases involving five or more parties. In short, the more complex the case, the less likely that a woman appeared as lead counsel.

Furthermore, the percentage of female attorneys appearing in court was nearly identical at the trial level (24.7%) to at the appellate level (25.2%). The problem is slightly worse downstate (24.8%) than upstate (26.2%). In New York federal courts, female attorneys made up 24.4% of all attorneys who appeared in court, with 23.1% holding the position of lead counsel. In New York State courts, women made up 26.9% of attorneys appearing in court and 26.8% of attorneys in the position of lead counsel.

"All these survey findings point to the same conclusion: female attorneys in speaking roles in court account for just about a quarter of counsel who appear in state and federal courts in New York. The lack of women attorneys with speaking roles in court is widespread across different types of cases, varying locations, and at all levels of courts."

I am the unabashedly proud father of two talented, intelligent and caring women. I taught them from the day they could listen that they could do anything they want in life. The fact that my own profession and calling may not allow that opportunity is deeply troubling and I ask everyone to reflect on what we all can do to improve things. Identifying and recognizing the problem is the first step toward a solution. If not now, when?



# Alicea Schools Community Engagement

Syracuse City School District Superintendent Jaime Alicea had a message for the OCBA Community Engagement Committee during a recent meeting.

If a lawyer has time to commit to the local school district, said Alicea, "we'll take you."

"It would be great if I could have someone who will come to the schools and provide services for our families on site," he said.

In an outreach effort for both the local public school system and for one of OCBA's most active committees, members met with the superintendent to learn how they could help the school district.

Clear to all present was Alicea's commitment to his 21,000-student and roughly 4,000-employee constituency whose employment and operational costs are covered by a \$417 million annual budget. A 33-year employment legacy within the district deepens the superintendent's understanding of the school system's composition.

"We're serving kids with a diverse background with needs not being met in the community," Alicea said. Community Engagement Committee members learned that annually almost 9,000 of the city's elementary school aged children receive extra services to boost reading and math levels.

"Only 13 percent are passing at level three or four on the ELA (English Language Arts) and 11 percent in math," Alicea explained. "We know we have to do a better job."

His goal this year? For all second-graders to read "on level," rewrite curriculum and incorporate professional development initiatives and, he said, "We are working with our families."

Facilitators from the district's Office of Family Engagement provide a helpful path toward open and direct communication between parents and district officials. Ten additional social worker assistants hired this year work

in elementary buildings, neighborhoods and visit student homes linking families to appropriate services. Extended after-school programming keeps learners and teachers together too.

Academic assistance is provided for middle- and highschoolers via Career and Technical Education (CTE) training. Seven years ago only six courses were available now there are 24 offerings.

In response to the region's development as a drone air corridor, Syracuse schools offers the state's

first high school unmanned drone program at the former Fowler High School, now the Public Service Leadership Academy.

"We are offering programs in preengineering, fire rescue, police services, PTECH, medical fields," Alicea said. "We are trying to provide different programs to engage our kids and our families to offer them more opportunities to graduate from high school."

OCBA members listened intently to Alicea's early-fall report card and those with questions raised their hands.



Denny Baldwin wanted to know if students interested in becoming carpenters and electricians were being served. Alicea described a welding program offered at Corcoran High School and a natural resources program plus a construction trade program at Nottingham High School.

"This year we opened a 'Grow Your Own Teacher' program and hired 240 new teachers," Alicea said, describing a new certificate program. "Our kids, by the time they finish, will qualify to be teaching assistants in the district. ... Hopefully they will stay in Central New York and take a job with us."

Director of the Syracuse University College of Law, Children's Rights and Family Law Clinic Suzette Melendez asked what the legal community could do for Syracuse schoolchildren.

"I have 21,000 kids, very diverse, we speak 84 languages in the Syracuse City School District. Every day we get new kids from the Middle East, from all over the world. Some of them are coming in


with interrupted instruction, no instruction. We have to do the best that we can to get them to graduate. A lot of them have some issues and we would like to provide those services," he said.

Five nationality workers, each speaking about five different languages means every community workshop and appointment is translated for the roughly 2,400 non-English speaking students and their families. Alicea acknowledged the district's need to one day offer adult and parent education, but said it faced limits to do so with state monies scant and only \$40 million in Title I funds provided annually from the federal government.

Safely transporting school-aged children to class is the current priority, the superintendent said.

"I have kindergarten kids walking a mile and a half and I have high school students also walking a mile and a half. In order for us to reduce this we need \$9 million more," Alicea said.

"We hope that Washington is going to realize that the future of this country depends on the education that we provide all the kids and they will continue to support public education."



# Legal Aid Societies Announce Immigration Fellowship

Roadblocks to a smooth immigration process pop up throughout the course of a New American's arrival to the United States. When that path gets rocky an attorney's help is like a beacon's guiding light.

The American Immigration Lawyers Association boasts a membership of 15,000 attorneys, 200 are associated with the Central New York chapter. Soon, one more legal professional may be added to those ranks.


The Volunteer Lawyers Project of Onondaga County announces it is accepting applications for a yearlong Fellowship for an attorney eager to provide immigration legal services.

"Syracuse is home to more than 10,000 refugees and even more undocumented farm workers," said Herve Comeau, an OnVLP staff attorney.

"Though almost every private immigration attorney in Syracuse volunteers with our program. it still isn't enough. This position will go a long way towards providing support to the immigrant community."

Sponsored through Equal Justice Works/Americorps the New York State Security Project Legal Fellow will work closely with the staffs of both VLP and the Hiscock Legal Aid Society. This lawyer will screen clients, prepare immigration applications, provide legal advice and aid, plus educate the community on immigration law and policy. If funding is sustained, the possibility exists for the Fellowship to extend past a single year.

"Through this Fellowship this person will gain experience, and mentorship. Working alongside some of the most experienced immigration attorneys in Syracuse," said Comeau. *Learn more about this opportunity by reading the job description below.*

The Volunteer Lawyers Project of Onondaga County is hosting a one-year Fellowship sponsored by Equal Justice Works designed to foster family security and community education through the provision of immigration legal services. The attorney selected for the Fellowship will be housed at the Volunteer Lawyers Project of Onondaga County's local office in Syracuse, NY. Per Equal Justice Works/AmeriCorps guidelines, the Fellowship must begin no later than January 1, 2018 and last for one year.

#### Fellowship Description: The Equal Justice Works New York State Family Security Project Legal Fellow will:

- •Represent clients in immigration court and before U.S. Citizenship and Immigration Services (USCIS)
- Provide screening and intake
- Prepare immigration applications
- •Provide brief legal advice and legal aid
- •Educate the community on the impact of evolving immigration law and policy
- •Engage pro bono attorneys and law students to provide legal assistance to immigrants and their families
- •Position is a one-year Fellowship, with a possible one-year extension contingent upon continued AmeriCorps funding.

#### Qualifications: The ideal candidate will have the following:

•The ability to undergo and pass AmeriCorps-mandated criminal background checks (only conviction for murder and/or presence on sex offender registry are automatic bars to service; other criminal convictions are allowable pursuant to Equal Justice Works review and approval)

•A demonstrated commitment to public interest work and strong desire to assist indigent clients

- •Strong writing, communication, interpersonal, and organizational skills
- •The ability to work collaboratively in a variety of contexts
- •Prior experience in managing independent projects or assignments
- •Law school clinic, externship, summer or other relevant practice experience a plus
- •The ability to begin the fellowship no later than January 1, 2018.
- •Proficiency in a second language such as Spanish, French or Arabic preferred
- •Those with experience in regards to immigration issues strongly encouraged to apply

•Willingness to attend a mandatory substantive immigration law training in New York City in January 2018, as well as the mandatory Equal Justice Works Leadership Development Training in Washington, DC in October 2018 (Note that travel costs for these trainings will be covered by Equal Justice Works)

•Must be currently admitted to law or be admissible shortly after beginning employment.

The Fellow will receive annual living allowance, as well as financial support for housing, student loan repayment, and other permissible reimbursable living expenses. # FloridaResidency:

It Doesn't Have to Change New York State Charitable Giving

Fall is here and Central New York snowbirds are making travel plans to flee the Empire State. While weather is certainly one reason to fly off to Florida, many snowbirds are heading south for another reason – to establish or maintain their non-New York residency for tax purposes. Recent changes in the law have reduced the impact of New York estate tax, but New York's high income tax rates remain a strong motivator to establish residency outside New York.

New York taxes its residents on income from all sources. On the other hand, nonresidents are only subject to tax on income derived from New York sources. Therefore, an individual who can establish legal residency outside New York will eliminate or at least minimize his exposure to New York tax.

There is a common misconception that charitable giving also needs to be adjusted during this process. Thomas Griffith, director of gift planning at the Central New York Community Foundation, reports that he often sees donors who change their tax domicile to Florida mistakenly thinking they need to cease their gifts to charities here in Central New York to avoid New York taxation. Let's look at this more closely.

Section 605(b) of the New York Tax Law determines a taxpayer's residency status. The initial question is whether the taxpayer is "domiciled" in New York. Although in everyday conversation "residence" and "domicile" are used interchangeably, here they have different meanings. "Domicile" is the place an individual intends to make her permanent home – the place to which she returns after absence. And though a person may have several residences, she may only have one "domicile."

These are the five primary factors to determine domicile under New York Law: the pattern of use of the New York residence; the taxpayer's New York business ties; where the taxpayer spends her time; the physical location of items "near and dear"; and the location of family. Even if a taxpayer is not considered "domiciled" in New York, the snowbird may still be taxed as a New Yorker if he spends more than half the year (or 183 days) in New York, and maintains a New York yearround residence.

To help snowbird clients navigate these complex rules, advisors have developed widely used checklists of "do's and don'ts". Often included in such lists is the recommendation that clients sever all ties with local charities. In response, clients have shifted their charitable support out of state, ceasing donations to organizations they and their families have supported for decades, and perhaps generations.

This is not the intent of New York law. In fact, advisors and clients will be reassured to know the New York Tax Law and published tax audit guidelines specifically state that where a taxpayer volunteers and to what charity a taxpayer donates are not relevant in determining the taxpayer's domicile. The New York legislature amended Section 605 of the Tax Law in 1994 to clarify that charitable support and volunteer work "shall not be used in any manner to determine where an individual is domiciled".

Professional advisors should revisit and revise their guidance to reflect this information. Surely, clients will welcome this news – one less item on the snowbird checklist and, more meaningfully, a green light to continue supporting the charities they have supported their entire lives.






