VALAC Donates to Second Chance Canine Adoption Shelter

There is room for both man and beast in the hearts of VALAC volunteers.

Members of the Volunteer Advocate Lawyer Animal Abuse Court are attorneys who represent a variety of practice areas, but the one they have in common revolves around man's best friends.

And like their clients, these lawyers are devoted and true and this year have saved 9 dogs and 11 cats from negligent, abusive owners and hellish homes.

Founded in 2016 by criminal defense attorney and former prosecutor Nicholas DeMartino, VALAC continues to put pets first and is a frequent first line of defense against abandonment or being euthanized.

The role of a VALAC is to be an animal law guardian who's responsible for monitoring the legal status of an abused animal from the moment a Syracuse Police Officer issues an appearance ticket.

On a rotating schedule, VALAC attorneys are assigned to make an animal welfare check by visiting dogs that have been taken to one of two animal hospitals. They observe and report on its physical and emotional health. In some cases, VALAC's also pursue ownership termination as they communicate with the district attorney's office throughout the animal's legal journey. The good word is out about VALAC and monetary donations from animal lovers flow into the bar association on a regular basis. This year' holiday food and treat drive saw Joyce Glass, a Nassau County resident and enthusiastic VALAC follower, ship two large boxes of dog food from her Long Island home.

The VALAC program is gaining traction and is becoming a model of similar programs across the state. In 2016, the American Red Cross named DeMartino a "Real Hero" for the creation of the program that strives to bring justice to those who truly have no voice.

Clarity for the Fee Dispute Resolution Program

The Fee Dispute Resolution Program (22NYCRR §137.6(a)(1)) was established to provide an informal and expeditious process for the resolution of the fee disputes between attorneys and clients. The program as established is mandatory for all disputes regarding attorney's fees except those involving amounts less than \$1,000.00 or more than \$50,000.00; matters involving criminal representation; fees set by Court Order, statute or regulation and other categories. Recently the rules governing the Fee Dispute Resolution Program were amended.

Effective January 1, 2018 the arbitration procedure required under the Program (section 137.6) will not only apply where there is a dispute regarding attorney's fees, but will also be applicable "where the attorney seeks to commence an action against the client for attorney's fees." The purpose of this change is to clarify that unless expressly exempted under the rule, attorney's must provide clients notice of their right to arbitrate even where the client has not explicitly disputed the fee.

As a result of this change proper practice dictates that a client be provided Notice of Right to Arbitrate wherever a fee dispute exists or prior to commencement of a fee collection action.

The Onondaga County Bar Association is the Administrator of the Fee Dispute Program for the 5th Judicial District. The notice of "Right to Arbitrate" to provide to clients, as well as procedures for the Program can be found <u>here</u> or through the OCBA.

Skill Building: Releford Ascends from Paralegal to Top Watchdog

anette Releford leveraged her experience and training as a paralegal to land a new role in the Syracuse community.

In June, Releford was named the administrator of Syracuse's police oversight agency, the Citizen Review Board. She runs the day-to-day operations of the 11-member panel of citizen-volunteers who investigate grievances brought by members of the public against the city's police department. Complaints that potentially violate local, state and/or federal law range from allegations of excessive force and constitutional violations to harassment and racial and gender bias, among others.

After review and deliberation, in hearings, the disciplinary recommendations the CRB makes may include officer retraining, counseling, written reprimands, suspensions, loss of paid vacation, or termination.

In 2016, the municipal body received 109 complaints and held 25 hearings resulting in 14 sustained findings against one or more officers. A sustained finding indicates the panel found substantial evidence of alleged misconduct.

"The CRB was created so citizens could have an avenue to express grievances and I envision it will continue to serve the public as best it can and hopefully decrease the number of complaints," said Releford. "So the community and the police relationship becomes better."

Making the switch from law firm to governmental agency requires Releford keep a flexible schedule. Now, she juggles regular monthly meetings of the entire board that are open to the public, and arranges five public outreach meetings in each Common Council district. Additionally, she creates a CRB presence at community events such as Juneteenth, CNY Pride Festival, and the Westcott Street Cultural Fair.

When working with the public, Releford accesses her knowledge of the Syracuse legal community and guides clients toward critically needed resources such as the services provided by Hiscock Legal Aid Society or the Volunteer Lawyers Project.



Working full-time in the legal profession while also pursuing her paralegal education "clicked" for Releford. The chops that made her a topnotch paralegal professional continue to serve her in her new job such as investigative and file maintenance skills, plus exposure to a variety of law practice areas.

Being a member of the Paralegals Committee broadened her world of reference and helped her feel well rounded.

"By coming to the different luncheons we have, those give you a variety of different skill sets in different areas of the law and I've been able to then utilize those things," she said.

Releford pursued her paralegal education in 2011, when she was a member of the last graduating class of the University College Paralegal Studies Program at Syracuse University. Following stints focusing on Social Security Law at the Olinsky Law Group and in Bousquet Holstein's Litigation Department, she gained her master's degree in paralegal studies in 2015 from George Washington University.

A turn in the city's law department inched her closer to the CRB gig. She was already familiar with the agency from her days at Bousquet Holstein as it represented the agency in a lawsuit against the police department.

"As a paralegal at Bousquet, I helped with that litigation so that when I saw that the Citizen's Review Board was looking for an administrator I decided to apply. And lo and behold, I got the position," she said.

"When opportunities present themselves and you know your skills can go in different directions leap out there and take the jump."

"I feel like I'm able to give back to and help the community."

She didn't see it coming, but Sally Fisher Curran recently received surprise recognition from her peers at the Gifford Foundation and the Allyn Family Foundation.

On November 1st, Curran joined colleagues and friends at the Marriott Syracuse Downtown to see who would be named the 2017 Kathy Goldfarb-Findling Leadership Award recipient.

Little did she know the intended honoree was the Volunteer Lawyers Project executive director herself.

"The Kathy" is jointly bestowed by the two foundations to a nonprofit leader whose creativity and talent for collaboration propels them toward making positive changes for Onondaga County residents.

Curran and the award's namesake never met, but those who knew Goldfarb-Findling say the duo would have cottoned to one another.

"We have heard from many people how much they wished Kathy had known Sally," said Heidi Holtz, Gifford

Foundation Director of Research and Projects.

The award is a salute to those who employ a nimble and creative leadership style, encourage life-long learning, and confidently take leaps of faith in the name of positive growth.

"Sally's nominator celebrated her community commitment, non-profit partnerships, embrace of new

opportunities and belief in diversity, all qualities Kathy Goldfarb-Findling shared," said Dirk Sonneborn, Gifford Foundation Executive Director.

While the foundations feted Curran for her accomplishments on behalf of VLP and her service on the boards of the OCBA and Central New York Women's Bar Association, as well as her committee work with the New York State Bar Association on its President's Committee on Access to Justice, and Committee on Legal Aid and Pro Bono Coordinators Network, the \$3,000 "Kathy" honorarium is meant to be spent on personal initiatives and not on professional pursuits.

Delighted to receive the award Curran was especially surprised to see her parents, who made a special trip

to Syracuse from Maine, welcomed at the ceremony. She says a "Belief in transformative change, the power of collaboration, and a positive strengths-focused attitude," are the leadership concepts she keeps foremost in mind.

We asked Curran what's ahead for VLP in 2018.

"There are so many things I'm excited about for the Volunteer Lawyers Project. We're engaged in the Gifford Foundation's ADVANS program, which will allow us to do a deep-dive analysis about our organizational capacity and help us grow. We will be significantly expanding our Eviction Defense work, having a full-time attorney focused on supporting the incredible work our volunteers do and engaging in significant efforts to prevent eviction before anything is filed in court. Our Immigration Program will be growing this coming year with an Americorps Legal Fellow, and I'm optimistic we will be able to implement an asylum pro bono panel. We've recently expanded our Homeless Advocacy Talk to a Lawyer Programs to Cayuga and Oswego Counties, and I'm hopeful we will be able to continue to expand the pro bono opportunities we're providing throughout Central New York to additional lawyers and in doing so expand access to justice in the region. And we're excited to continue to work on creating opportunities and pathways out of poverty through our community economic development work - both our low-income entrepreneur and our job readiness (re-entry) programs are going full speed and I'm hopeful we'll be able to expand both in 2018. The community needs are huge, but the number of pro bono attorneys and law students engaging in pro bono grows every year, making more work possible.

We hope Onondaga County Bar Association members will consider including the Volunteer Lawyers Project in their year-end donation plans. We really do leverage the money given to provide service to so many."





The Kathy Goldfarb-Findling Leadership Award "The Kathy" is short for the Kathy Goldfarb-Findling Leadership Award, jointly sponsored by the Gifford and Allyn Foundations. It is named for the Gifford Foundation's late executive director who also served as the Allyn Foundation's director of strategic services. Re: New York State Courts Electronic Filing Program

Dear Counsel:

Pursuant to Section 212 of the Judiciary Law, the Chief Administrative Judge of the State of New York must submit to the Legislature, the Governor, and the Chief Judge an annual report evaluating the state's experience with electronic filing and containing recommendations for further legislation. In connection with the preparation of this report, which is due February 1, 2018, I write to invite comments about the implementation of the c-filing program.

Lan also inviting comments on proposed legislative changes that we are considering for inclusion in the February report. The changes under consideration relate to the authority of the Chief Administrative Judge to expand mandatory e-filing. Under current law, the Chief Administrative Judge decides the courts and case types in which e-filing should proceed. Mandatory e-filing, however, is prohibited in certain civil case categories in Supreme Court, such as matrimonial, election, Article 78 and Mental Hygiene Law cases, and in many case types in New York City Civil Court. We are considering a proposal that would eliminate some of these restrictions.

If any of the current legislative exclusions from mandatory e-filing were eliminated, a mandatory program could be implemented by order of the Chief Administrative Judge issued only after consultation with the Bar, the legal services providers and other groups. Moreover, in Supreme Court, the consent of the County Clerk of an affected county outside New York City would be required.

This proposal would not affect other existing provisions in the e-filing legislation. For example, unrepresented persons would continue to be exempt from e-filing unless they affirmatively choose to participate in a particular case. Also, attorneys lacking the necessary

equipment or knowledge would continue to have the right to opt out of e-filing. Furthermore, the e-filing system would continue to provide for confidential treatment of cases such as matrimonial actions.

I would like to make a request of your membership that you help our office with processing cases you file. You can do that by accurately filling out the Request for Judiclal Intervention (RJI) form and the appropriate addendum. This form was developed to assist our office in properly moving your case though the court as expeditiously as possible. It provides us with the information required to properly input the data into our case management database, gives us information about the case so it can be properly assigned, it tells us about related cases, and much more valuable information. The addendum for matrimonial actions is particularly important because it provides us with information we require to do records checks. This document follows the case from filing through and is used by the Justices, Judge's staff, Court Clerks, Court Reporters and other court staff. When you file the RJI you know the case very well, have managed the case sometimes for a period of time and have produced volumes of documents. We are asking is that you, through this form, provide us with an accurate brief summary of Information we need to make sure there are no undue delays in processing your case. I can not stress how important it is to accurately complete the form and the proper addendum.

The Request for Judicial Intervention form and addenda for use in civil practice in the Supreme and County Courts are available in both plain and fillable document formats on the nycourts.gov website. The forms include the RJI itself (UCS-8400), a general addendum (UCS-840A), and specialized addenda for Commercial Division (UCS-840C), foreclosure (UCS-840F), and matrimonial matters (UCS-840M). Additionally, there is an Uncontested Matrimonial RJI (UD-13), which is an abbreviated version of the form used exclusively in

uncontested divorce matters. Please note that fillable forms may have a slightly different appearance due to the use of form fields and controls (i.e., drop-down menus, radio buttons, etc.).
