## There's a New CLE Credit Category in Town

It's a new CLE year! And it's an ideal time to review what's new in the world of Mandatory Continuing Legal Education.

As of January 1, accredited CLE providers across the state began issuing credit in a new MCLE category – Diversity, Inclusion and the Elimination of Bias.

OCBA was among the first in the region to do so. On January 11th, in a happy collaboration, the Central New York Women's Bar Association and OCBA's Family Law Section sponsored the CLE Advanced Topics in Family Law: LGBTQ Parentage and Advocating for Clients Experiencing Poverty and Domestic Violence, which offered one credit in the new MCLE category.

We look forward to offering this new credit in future seminars. Following is specific information, per the NYS CLE Program Rules, that both experienced and newly admitted attorneys need to know about gaining this new MCLE credit.

#### **Experienced Attorneys**

#### What is the new Diversity, Inclusion and Elimination of Bias CLE requirement?

Experienced attorneys (those admitted to the New York Bar for more than 2 years) must complete at least 1 CLE credit hour in the Diversity, Inclusion and Elimination of Bias CLE category of credit as part of their biennial CLE requirement.

#### Does the new Diversity, Inclusion and Elimination of Bias requirement increase the total number of CLE credit hours that experienced attorneys must complete during each biennial reporting period?

No, you will continue to be required to earn a total of twenty-four (24) CLE credit hours in each biennial reporting period, with at least four (4) CLE credit hours in Ethics and Professionalism; and, effective July 1, 2018, with at least one (1) CLE credit hour in Diversity, Inclusion and Elimination of Bias.

#### When must I begin to comply with the new Diversity, Inclusion and Elimination of Bias CLE requirement?

The new requirement becomes effective July 1, 2018. Experienced attorneys due to re-register on or after July 1, 2018 (birthday is on or after July 1st) must comply.

#### May I carry over CLE credits from one biennial reporting cycle to the next?

Once an experienced attorney has completed the 24 CLE credit requirement, a maximum of 6 additional credits earned may be applied toward the next reporting cycle. Experienced attorneys may carry over credits in any category, including Ethics and Professionalism and Diversity, Inclusion and Elimination of Bias credits from one cycle to the next.

#### Newly Admitted Attorneys

Am I required to earn Diversity, Inclusion and Elimination of Bias CLE credit hours as part of my newly admitted attorney CLE requirement?

Although you are encouraged to participate in such programs, the transitional CLE requirement for new attorneys (those admitted to the New York Bar for 2 years or less) remains unchanged. It does not include a Diversity, Inclusion and Elimination of Bias CLE credit component.

#### Can I earn credit in the Diversity, Inclusion and Elimination of Bias CLE category of credit for attending diversity programs in order to apply the credit toward my first experienced attorney CLE requirement?

No, only experienced attorneys may earn credit in the Diversity, Inclusion and Elimination of Bias category of CLE credit for diversity programs.

# What You Need to Know:

#### **Definition:**

22 NYCRR 1500.2(g) - Diversity, Inclusion and Elimination of Bias (g) Diversity, Inclusion and Elimination of Bias courses, programs and activities must relate to the practice of law and may include, among other things, implicit and explicit bias, equal access to justice, serving a diverse population, diversity and inclusion initiatives in the legal profession, and sensitivity to cultural and other differences when interacting with members of the public, judges, jurors, litigants, attorneys and court personnel. [Effective January 1, 2018].

#### Partial Credit and Repeat Attendance:

(From the NYS CLE Rules and Regulations)

THE RULE: (C) Limitations on CLE Credit Awards (1) Partial Credit — Credit shall be awarded only for attendance at an entire course or program, or for attendance at an entire session of a course or program. No credit shall be awarded for attending a portion of a course or a portion of a session. (2) Repeat Attendance — No CLE credit hours may be earned for repeating the same course or program, in any format, even if the course or program is repeated in a subsequent reporting cycle. THE EXCEPTION: Sections 2(D)(1) and 3(C)(1) of the Regulations and Guidelines permit the issuance of appropriate credit in circumstances where the attendee has missed a portion of a presentation due to unforeseen events, provided the attendee received the full educational benefit of the portions of the presentation actually attended. Examples of unforeseen events might include unanticipated weather or traffic situations or a family health emergency that delay an attendee's arrival at the course, or require an attendee to leave the course early. Common sense should be used by the provider; missing two or three minutes of the introductory portion of a presentation would not provide sufficient grounds, for example, to deny full credit to an attendee where the attendee has received the full educational benefit of the presentation. Conversely, however, full credit should not be awarded where an attendee's absence precluded the attendee from receiving the full educational benefit of a presentation. The second issue relates to CLE credit for attending the same program on more than one occasion. (Sections 2(D)(2) & 3(C)(2), Regulations and Guidelines) The Board recognizes that many continuing education courses will be somewhat redundant and repetitive. Where a CLE program has new content, such as revised or updated materials reflecting recent changes in the law, the attendee should receive CLE credit. It is the intent of the CLE Board to deny CLE credit only in situations where attendees seek CLE credit for repeat attendance at the same program where the content is unchanged.

## New Clients Come By Way of Lawyer Referral Service

ype "I need an attorney in Syracuse" into any search engine and you'll be overwhelmed by the results.

If your next client is that Google searcher he or she might find you if they're patient enough to wade through all the links ahead of yours before becoming intimidated by the process and chucking it altogether.

Or, to help find the right fit, maybe your phone number is more easily found if that potential client first speaks to someone with knowledge of local legal professionals, their practice areas and specialties.

The OCBA Lawyer Referral Service fills this need.

Stuart J. LaRose, LRS Committee Chairman, explains:

"Members who become LRS panelists receive referrals from paying clients who have been prescreened as to type of legal matter and who understand it is not a free service," he said. "Clients receive a referral to an attorney in the area of their need with an assurance from the Bar that the lawyer is insured and meets standards of practice in that legal area allowing them to accept a referral."

The LRS has been an added feature of bar association membership for more than 20 years. In 2017, the LRS answered more than 3,000 calls, making more than 1,500 referrals to 72 panelists who earned a total of \$685,634 from these new clients.

Callers are pre-screened to determine the particulars of their possible case. Referrals are made on a rotating basis so the next available attorney listed per requested category is offered to a caller. The first brief consultation is free. If the attorney takes on the case, he or she agrees to remit to the LRS 10 percent of the referred case's total fee upon its resolution.

"In most cases, someone calls for, say, an uncontested divorce. They may be quoted \$500. Our LRS requires a 10 percent referral fee of all cases that close. That divorce case would owe the LRS \$50 – and that attorney has cleared their initial investment by half," said LRS Director Maggie James.

Those for whom referrals cannot be made are redirected to one of several local legal aid services, a Talk-to-a-Lawyer site, or to a governmental agency.

"Even though we don't offer pro bono services here, we do fill quite a gap for people who are not familiar with the law," said James. "Some don't even know what kind of case they have."

As a former small business owner, whose work with attorneys for the last five years has exposed her to a wide variety of legal subject matter, James has taken to the role of managing the LRS. With only the lessons life can teach a person, she listens to callers whose issues range from mild queries to frantic emergencies as she searches through her LRS roster for an attorney to help them.

This human interaction is what sets this bar association service apart from online legal technology services, said LaRose.

"People choose us over Legal Zoom because of the assurance that this is a local service, not an out-of-town corporation," he said. "There is an assurance the client has that the bar association vetted the attorney in keeping with LRS and American Bar Association standards."

Becoming an LRS panelist is simple. For an additional annual \$100 on top of standard OCBA membership dues, lawyers complete an enrollment form, select practice areas and sub-categories, sign an attorney affirmation, and provide a current copy of their Malpractice Insurance Policy to the LRS.

Longtime LRS panelist and former LRS Committee member Melody Westfall, of Scalfone Law, has a unique perspective of the effectiveness of this program, her strong link to it has netted her dozens of clients.

"It goes without saying that once those contacts have become clients, they have become longtime clients, and come back to us time and time again when they are in need of legal advice," she said. "For those I cannot assist because my firm does not practice in those areas of law, I am able to refer them back to the LRS to get the appropriate legal representation that they need.
