





LAWYERS HAVE SPECIAL POWERS.

A lawyer's strength manifests in the ability to analyze points of law, categorize persons and places, recognize subtlety and deduce complexities. Many are well spoken; eloquence only adds to their mastery.

"Lawyers have super powers," claimed Reta Raymond, Staff Attorney with Legal Services of Central New York.

At the outset of a March 26th Central New York Immigration Coalition meeting, Raymond talked about why attorneys should

apply their skills to the organization.

Her light-hearted tone belied her real point, she said, which was that lawyers most often "use their powers for good."

"It's a great way to learn about various issues going on in immigrant communities," Raymond said.

Attorneys, like Raymond, who direct their solution wizardry toward the CNYIC mission find themselves working shoulder to shoulder with non-attorneys who are also masters of their domain: Social Workers, Civil Rights Activists, Labor Organizers, and Government Officials.

Topics at these forums invariably include updates on the Deferred Action for Childhood Arrivals Act and its possible predecessor the Dream Act, but also address specific issues such as language barrier mitigation, health care options, and healthy housing advocacy.

Robert Rubinstein, staff attorney with the Hiscock Legal Aid Society, thinks CNYIC meetings have appeal to both private and public lawyers because of "how inter-connected all these issues really are."

Job loss, for example, can lead to public assistance and housing issues which may lead to custody concerns. "And immigration plays into that," Rubinstein said.

For the last year, these like-minded colleagues have joined together quarterly to advocate on the part of the CNY immigrant and refugee population, which, for a host of reasons, may find themselves in need of sufficient housing, decent working conditions, an interpreter, or simply feeling safe.

"(Meetings) provide structure and a good space to discuss the needs of the community," said Herve Comeau, Immigration Staff Attorney with the Volunteer Lawyers Project. "They put everyone in a room to try to do some planning and to work together."

ADVOCATES ACTIVATE!

Headlining the meeting was guest speaker Robert Nassau, Esq., who teaches tax law at the Syracuse University College of Law.

By virtue of Internal Revenue Service grant monies, since 2002, Nassau and his students operate the law



Wishing to clue-in CNYIC members of key changes to the tax bill, Nassau explained the late-2017 approval of the Tax Cuts and Jobs Act means different things for different people.

"It's not good for undocumented aliens, but probably pretty good for other lower-income people," he said. "Lower income Americans will likely see more money in their pockets."

Significant to taxpayers, regardless of income levels, he said, are increases to the standard deduction and tax rate, but the main change are boosts to the Child Tax Credit and Family Tax Credit.

Previously \$1,000, the Child Tax Credit is now \$2,000 per Qualifying Child.

Nassau described how persons who don't have a Social Security number can still go about filing income taxes by virtue of an Individual Taxpayer Identification Number. This number is used for federal tax reporting purposes only and is issued regardless of immigration status to assist in efficiently filing tax returns and following up on payments due. Applications for ITINs can be achieved at the SUCOL tax clinic.

For undocumented persons concerned filing a tax return or applying for an ITIN may cue the interest of law enforcement, Nassau provided assurance.

"The IRS is not allowed to share any information with anybody," he said.

Next, Fabiola Ortiz, Manager of

Member Engagement with the New York Immigration Coalition, updated attendees on the push her organization is making to provide immigrants across the state with driver's licenses via the campaign Green Light New York: Driving Together.

Farmworkers who live within 100-mile radius of the border, for example, who need to get to the job, get children to school or the doctor, run errands, or exercise their independence are at risk for detainment when and if they're stopped by state troopers, border patrol agents and even park police.

"The reality is our communities are more at risk outside of New York City," she said.

BREAK-OUT GROUPS BRAINSTORM!

Education, housing, healthcare, and labor specialists break into groups to derive ideas of how to acclimate CNY's newest neighbors into their homes.

Social workers from Utica and Syracuse discussed questions they'd ask on a survey intended for teachers, parents, and students about access to translation and interpretation services.

"How can you expect people to be successful if you don't give them the building blocks to be successful," said Selma Jasencic of the Office for New Americans.

HLAS attorney Rubinstein, worked together with Barrie Gewanter,

Director of the local Commission on Human Rights, and the Peace Council's Peter Swords on introducing language access via interpreters inside doctor's offices and courtrooms.

"It's really important for people who speak different languages tell their story," said Swords. "Once people start to hear their stories things move."

Those discussing farmworkers issues sought ways to build up public awareness of the straits in which some workers find themselves related to transportation, fair wages, and housing.

John P. Steves, Assistant District Director of the Wage and Hour Division of the U.S. Department of Labor liked what he heard in his break-out group. His organization assists "vulnerable workers," he said.

"We hear them," he said.

"It's good for us to be a part of this."

What Your Estate Planning Clients Wish You Were Asking

early 75% of high net worth individuals consider charity to be an important consideration in their financial and estate planning, according to a survey conducted in 2013 by U.S. Trust. This sounds like good news for charities, but the data also highlights a breakdown in action by professional advisors that can derail these good intentions. Only about half of poll respondents reported having charitable conversations with their advisors, leaving a large margin of high net worth clients with an important goal that their advisors are not helping them to meet.

Sometimes charity is overlooked during planning because clients and advisors have to overcome both factual and psychological stumbling blocks.

What keeps advisors from having this important conversation?

- •A Focus on the Technical. Sometimes even in long-term client relationships, the advisor has not had many conversations about the client's values and charitable interests. Some advisors focus more on the technical aspects of the planning, making it hard to move into a more values-based discussion.
- •Lack of Knowledge. Some advisors lack extensive training on charitable planning techniques. Others may have learned about charitable planning at some point, but have not used their knowledge frequently enough in practice to be comfortable starting that conversation now.
- •**Hesitation to Engage Others.** Charitable planning often requires advisors to engage with the whole family rather than just their client. This may concern some advisors seeking to have clear boundaries around who they represent in those interactions.

What concerns make it difficult for your clients?

- •Fears of the Unknown. Some clients fear they might outlive their money, causing them to hesitate in taking action. Others worry they will leave their heirs with less than they intend. In reality, when done properly, charitable gifts can be included in an estate plan without a significant (or any) reduction to what is received by heirs.
- •Loss of Control. Clients sometimes have uncertainty about the nonprofits they want to support. They do not want to choose to support an organization and then be unable to change it if their interests change.
- Family Complexity. Each client has a unique family dynamic. This can sometime lead to difficulty holding a fruitful conversation with families about giving.

Family wealth and legacy planning, in the words of Tom Rogerson from Wilmington Trust, requires an integrated approach that allows a client to protect and grow their money, prepares money for their family and prepares their family for money. Philanthropy is a key factor for success in this work, since it provides a way for the family to connect around their values and work together to achieve impact.

BARCLAY DAMON SECURES \$61 MILLION WIN FOR PPC BROADBAND

On March 13, the Federal Circuit affirmed a willful infringement judgment secured by Barclay Damon for the Syracuse-based PPC Broadband Inc. in a \$61 million patent infringement case against a Corning Inc. subsidiary over coaxial cable connector technology.

According to Law360, the appeals court rejected Corning's claims that the district court made a "cavalcade of errors" in understanding patent language, and that its products did not infringe on any of PPC's designs "under the correct interpretation."

"We couldn't be more thrilled at the outcome," PPC attorney and Barclay Damon Intellectual Property Litigation Practice Area chair Douglas J. Nash said. "We believe this case is a strong reminder to competitors to uphold their integrity and think twice about violating patent protections."

The federal suit was the second brought against Corning by PPC, alleging in 2011 that while the subsidiary initially changed its product designs after a 2003 settlement agreement, it had secretly reverted back to the dual-patent infringing versions.

PPC was originally awarded nearly \$24 million in royalties after a three-day trial in 2015, but US District Judge Gary Sharpe later doubled the damages in November 2016, noting that the monetary adjustment was largely justified due to Corning's concealment of its "egregious infringement behavior."

While Corning argued that there was no legitimate cause for increasing the award, PPC countered that Corning had been caught infringing twice and the court "did not abuse its discretion in enhancing damages."

"It is rewarding, after all of the hard

work by our team of attorneys and other professionals, to obtain this significant and deserved victory for our client in protecting its patent rights," Intellectual Property Group leader Denis J. Sullivan said.

With interest, PPC's win totaled at \$61 million.

John P. Langan, Barclay Damon's managing partner, said, "This win is a testament to the outstanding teamwork and talent that separates Barclay Damon attorneys from the rest of the pack. Not only did we deliver a great result, but we demonstrated exactly why our attorneys are recognized as industry leaders."

The American Bar Association's Liberty Bell Award is the most prestigious award given by lawyers to a non-lawyer. The Award honors a person who has strengthened the American system of freedom and justice under law through their extraordinary contributions in the community. The announcement of the Award is one of the highlights of Law Day, a day set aside by the Congress to celebrate our great heritage of liberty, justice, and equality under law. In 2018, Law Day will be celebrated with a ceremony at the Syracuse University College of Law on Tuesday, May 1st.

The Liberty Bell Award is given for outstanding service in one of these areas: promoting a better understanding of our Constitution and the Bill of Rights; encouraging greater respect for law and the courts; stimulating a deeper sense of individual responsibility so that citizens recognize their duties as well as their rights; contributing to the effective functioning of our institutions of government; and fostering a better understanding and appreciation of the rule of law.

The Onondaga County Bar Association presents its local Award to an Onondaga County resident to recognize that person for contributions **outside his/her regular employment**, or for service **above and beyond** one's normal and expected work responsibilities if they are currently employed within the legal or criminal justice system.

<u>Non-lawyers</u> of any age are eligible to receive this award. Judges, lawyers, or other members of the State Bar of New York are not eligible. Persons holding or seeking public office, and previous Liberty Bell Award recipients, are not eligible.


