In no particular order, over the past year, we have:


- •Reformed and re-established our practice area Sections and Committees with new Co-Chairs and defined objectives,

Lisa Alexander at Paralegals Luncheon

Lisa Alexander, Senior Managing Counsel Upstate Medical University

On May 10, 2018, the OCBA
Paralegals section was lucky enough
to hear Attorney Lisa Alexander,
Senior Managing Counsel for
Upstate Medical University, speak
about not only her time as a
paralegal, but about the personal
difficulties she endured while
working to achieve her professional
goals. Lisa's presentation was not
only insightful and inspiring, but at
times raw, emotional and witty.

Lisa grew up in a small town in the Adirondacks, one of six children. It was a mock trial in 5th grade that lit a spark for her interest in the legal profession. After graduating high school, she was awarded a \$500 scholarship to Russell Sage College to play basketball (this was a time before Title IX came into play - no full ride scholarships for women's sports!) and to study in their two-year paralegal program. In the early 80's, there were not many paralegals working in the Albany area as attorneys either did not understand or have knowledge of their potential value.

Following her completion of the paralegal program, Lisa went

back to Russell Sage College to complete a secretarial program as she felt this would give her an edge professionally. During this time, she received a job offer from a local medical malpractice attorney. She quit the secretary program and accepted the offer. From there, as they say, the rest is history.

Her new employer saw the value of the work she performed as a paralegal – so much so that he inadvertently sent her to Court to argue several motions (several which she won) and encouraged her to apply to law school. Lisa worked two 12 hours shifts each week at a diner to support herself while pursuing her J.D. It paid off – the day she graduated, she became a partner in her former employer's law firm.

After a few years, she set off to open her own firm. She handled medical malpractice cases while also working as a public defender and law guardian to pay the overheard. A poignant moment in her career came when she won an over \$1,000,000 verdict for a client diagnosed with breast cancer and

not given all of the appropriate treatment options. Lisa herself is a breast cancer survivor and hearing her speak, it was obvious she is passionate not only about advocating for others but fighting for what she believes is right.

While running her own firm, Lisa endured another personal tragedy with the loss of her son. From there, it was time for her to make a change. She left the world of civil litigation and accepted a position at SUNY Upstate Medical University as their senior managing counsel. Lisa advises the emergency room medical residents on their legal questions, concerns and medical/ ethical dilemmas. She is on call for them 24/7. Every day is different and offers her the chance to break new legal ground. When asked if the parameters of her position sometimes felt too overwhelming or difficult, she smiled and said "No, not when you love what you do."

Her office has just hired their first ever paralegal who is scheduled to start at the end of May. Lisa, after all, knows the value a hardworking paralegal can bring to any practice.

BOBBY finds LOVE

Bobby deserved better.

The male Pit Bull found bloodied and wandering Syracuse's south side might have liked a consistent home life and a responsible owner who could be counted on for proper care and feeding. And he most certainly would have preferred fewer facial wounds.

Animals subjected to abuse and neglect provide heartbreaking evidence of a sad societal scourge: violence and anti-social behavior.

While law enforcement and courts across the country pursue perpetrators of animal cruelty and recommend appropriate punishment, the non-human victims of their anger and evil-doing, those that survive, are left to wait for either a new home or wait out their last days in overcrowded animal hospitals or, if lucky, meet a Volunteer Advocate Lawyer for Animal Abuse Court.

Bobby is lucky.

"He was probably destined to be euthanized, but for the good work of all those around him," Nick DeMartino said. "His wounds were horrible."

DeMartino is a canine owning criminal defense attorney whose passion for VALAC's mission has prompted awareness of the OCBA initiative by law enforcement and government officials throughout New York and beyond. He serves as director of the program.

VALAC volunteers are animal law guardians who advocate on behalf of creatures found by either City of Syracuse Police Officer Becky Thompson or Syracuse Animal Control Officer Jason Driscoll to be physically abused, emaciated, or abandoned.

A VALAC follows the fate of an animal-victim from initial veterinary triage to court dates providing reports to judges, prosecutors and defense attorneys. They assure their clients

receive any extra medical attention, move them into foster care settings and then, hopefully, toward adoption into a forever home.

In the case of Bobby, Thompson received a tip from a caller who thought the dog had been stabbed. The police officer found him ragged and untethered, but hanging around a group of chained-up dogs.

"There were definitely stab wounds and he was definitely involved in fights. I'm just not sure if he was a bait dog or a fighter," she said. "He was lucky to get out of where he was or he was doomed to die."

Longtime VALAC volunteer Colleen Gibbons, an associate at Bousquet Holstein, received the call to come to Bobby's aid at the Veterinary Medical Center of CNY. There, he would undergo surgery to install drains in the top of his head to relieve the abscesses forming there as a result of the many recent lacerations and nicks.

"His head looked like a watermelon," Gibbons said. The vet on duty, she said, couldn't determine how many battles the young adult dog had endured.

"He had the classic signs of being in dogfights," said VMC Administrator Marcie Marshall. "He had puncture wounds, his ears were chewed. There were scars on his legs."

For the roughly 10 days Bobby spent in the hospital, he was a stellar, if sore, patient.

"He ate well, he was quiet and nice and never argued with other dogs," Marshall said. "He was just a really good boy." When he did howl, staffers took to his cage, sitting with him until his bouts of pain or sadness subsided.

"He got lots of love," Marshall said.

Bobby was also neutered during his hospitalization. He couldn't be rescued without the procedure. The costs for his various surgeries were covered by VALAC, a 501(c)(3).







Occasionally, cost-sharing agreements are struck among collaborating rescue agencies wishing to see man's best friends' fare well.

The identity of Bobby's owner remains unknown and, as a result, there are no pending actions in his case, Gibbons said, which means the pup is adoptable.

Enter Syracuse University College of Law student Adam Martin.

VALAC was a known entity to Martin thanks to Gibbons, a 2017 SUCOL graduate. They'd worked together on the school's Student Animal Legal Defense Fund and Martin's gain from that experience is his new orange domestic housecat, Richard.

The cat lover was among the 5,370 people reached by VALAC's Facebook posts concerning Bobby's progress and calls for a potential new home. He was mending well and ready to be transported to Long Island where he'd be tended to by the volunteers of Unchained New York, a foster facility – he just needed a lift there.

Martin knew he was the man. He'd been visiting Bobby during his convalescence and had a free Sunday afternoon. Via consensus by all agency volunteers, Martin would ferry Bobby to a New Jersey location, about halfway to Unchained New York's Long Island headquarters.

"I couldn't waste the opportunity," said Martin.

Riding alone in the back of his double cab Toyota truck, Bobby was clearly nervous. Martin pulled off the highway and brought the dog forward to sit with him as he drove. "He laid down with his head on my lap the whole way," he said. "He was very loving and gentle."

Thanks to the efforts of the many local and statewide volunteers eager to help him, Bobby, just like other VALAC clients before him, found his way out of the dangerous and inhumane situation he had no part in creating for himself.

"It was truly an amazing feat," DeMartino said of all parties involved in Bobby's rescue. "They did a bang up job." Bobby is currently enjoying a foster home full of soft couches and warm sunshine.

VALAC's Mission

The Animal Advocacy Program exists as a subsidiary to the Onondaga County Bar Association's Volunteer Advocate Lawyer for Animal Abuse Court (VALAC) Program. A VALAC is appointed when a criminal abuse case is pending. The role of the VALAC is to be an "animal law guardian," who is responsible for monitoring the legal status of an abused animal from the moment an appearance ticket has been issued. The VALAC monitors the health and emotional status of the abused animal, and assesses ownership issues; if necessary, the VALAC will seek termination of ownership rights. The VALAC will then provide this information to the Court, the District Attorney's office, and to the Defense Attorney. We anticipate law students in the Animal Advocacy Program will shadow and assist in each case as the assigned VALAC deems appropriate.

Shadow's Fund



This puppy was rescued by Syracuse Police Officer Becky Thompson on February 23, 2018. He was found severely emaciated and weak. There were also signs that he had been beaten. The dog was taken immediately to the hospital for emergency medical treatment. He passed away early the following morning due to severe health complications. We've named him Shadow because he sadly left us as quickly as he came. As a result, VALAC has started a fund in Shadow's memory to assist abandoned dogs who are in need of immediate medical care. The Onondaga County Bar Association (OCBA) is seeking nominations for the 2018 Distinguished Lawyer and Ruger Centennial awards. We have been honoring a local attorney for distinguished service to the profession since 1968. The Distinguished Lawyer Committee reviews written nominations and recommends a candidate to the OCBA Board of Directors for its approval.

In order to qualify for nomination, the lawyer

- must have devoted a full-time professional career to the law;
- (2) must possess exceptional lawyering skills;
- (3) must display a devotion or dedication to the profession as evidenced by involvement or participation in projects or activities, reflecting an unselfish donation of time to the betterment of the profession; and
- (4) must possess ethics beyond reproach.

The Distinguished Lawyer Committee is also accepting nominations for the William C. Ruger Centennial Award, created during the OCBA Centennial in 1975. The Ruger Award was named after the first president of the OCBA, who later served as Chief Judge of the New York State Court of Appeals. This award is given to a judicial officer and is "reserved for recognition of singularly outstanding achievement in devotion to the principles of our system of justice." Since the creation of this award, only eight jurists have been its recipients.

We are always seeking to expand our search for nominations and hope that you can help us. There is no specific form for nominations. Simply send a letter, including the name of the attorney or jurist, a resumé, and a description of why the individual meets the above criteria for either The Distinguished Lawyer or Ruger Award. Nominators are encouraged to include any supporting information that may be helpful to the Committee.

Nominations may be submitted to the OCBA office, at the above address, in care of, Gioia A. Gensini, Chair of the Committee. The deadline for nominations is Friday, June 22, 2018. The Sixth Judicial District has successfully implemented e-filing programs in Supreme Court in Broome, Chenango, Cortland, and Tompkins Counties. The implementation of the mandatory e-filing program will include all new civil actions, except:

- CPLR Art. 70 proceedings
- CPLR Art. 78 proceedings
- Election Law proceedings
- matrimonial matters
- Mental Hygiene Law matters
- consumer credit transactions as defined in CPLR 105(f)*
- residential foreclosure actions as defined in RPAPL § 1304*

 (*except initial filing of commencement papers by a represented party, which is mandatory)

The District Administrative Judge of the Sixth Judicial District and the Otsego County Clerk additionally propose to implement a consensual e-filing program composed of the seven case types listed above that are not subject to mandatory e-filing, and to also include the consensual e-filing of **documents filed subsequent to commencement papers** in consumer credit transactions as defined in CPLR 105(f) and residential foreclosure actions as defined in RPAPL 1304.
