



Jillian McGuire Receives WBASNY Recognition for Pro Bono Service

arlier this month, the Women's
Bar Association of the State
of New York honored OCBA
member and Onondaga County
Bar Foundation Treasurer Jillian
McGuire with the Hanna S. Cohn
Pro Bono Award.

The accolade recognizes the service of women who exemplify the work and mission of Hanna S. Cohn, who for 20 years built the Volunteer Legal Services Project in Rochester from a modest entity to a program of more than 900 active attorneys before her death in 2002.

McGuire earned the honor because of her successful and continual work on behalf of low-income women and families subjected to domestic violence, financial peril, and other Matrimonial and Family Law matters – who might not

otherwise find justice, or peace, without her pro bono assistance.

In her award acceptance speech, McGuire acknowledged the generosity of her employer, Mackenzie Hughes, for its latitude in giving her space and time to commit to these pursuits.

"That speaks volumes to their commitment to the Syracuse community," she said.

She spoke also of what it means to her career to be exposed to new practice areas and legal concepts that volunteerism affords.

"Doing pro bono work has made me a better lawyer," she said.

For the last five years, McGuire has shared her legal expertise with the constituents of the Volunteer Lawyers Project Family Court

Project and its Landlord Tenant Court Clinic.

"Each case has allowed me to use the privilege of my law degree to help those who might be excluded from accessing our justice system. This is such an important part of our profession," she said when she accepted the Cohn Award.

Apart from her full time work as a Family Law attorney in Mackenzie's Domestic Relations Department, McGuire has worked on 76 specific cases and donated more than 150 hours of service to VLP clients.

"Jillian's pro bono advocacy particularly stands out in her family law work," wrote Sally Fisher Curran, VLP Executive Director, in her endorsement of McGuire. "Jillian has taken on two particularly challenging cases, spending dozens of hours advocating for clients who had nowhere else to turn. One case involved a woman who had suffered from domestic violence by her husband who was trying to change the venue of her divorcee matter so that she wouldn't have to continue to return to the town where the abuse occurred for so many years."

Curran continued, "Another case involved assisting a lesbian couple complete a second parent adoption, which allowed them to finally have their family relationship recognized."

In 2014, McGuire received VLP's Distinguished Pro Bono Service Award.

Additionally, McGuire commits her energies to service on the Board of Directors of the Hiscock Legal Aid Society serving as Chair of its Board Development Committee, and is the secretary of the Central New York Women's Bar Association.

Every day, McGuire brings with her to work the altruistic sensibilities first forged during her childhood when she watched her parents volunteer in their church community.

"What gifts you have received, you pass on to others," she said.

McGuire is a Syracuse native who returned home in 2013 after a seven-year practice in Maryland following her graduation from

Washington & Lee University School of Law, where she was the 2006 recipient of the Women Lawyers Award, given to an outstanding woman law student. She is a member of the College of Holy Cross Class of 2003, cum laude.

From 2014 through 2017, she was designated an Upstate New York SuperLawyer "Rising Star," and was this year awarded the Central New York Women's Bar Association "Rising Star" honor.

She and her husband Chris have the pleasure of raising three children Maggie, Alice and Declan, who are all under the age of four, and when she can, this enterprising lawyer likes to coach soccer and lacrosse.

Charitable Giving After Tax Reform

There is an old adage: the more things change, the more they stay the same.

Passage of the Tax Cuts and Jobs Act last year led to a fair amount of speculation and anxiety about the impact of tax reform on charitable giving – and the charities that rely on it. According to Giving USA, an organization devoted to analyzing charitable giving in the United States, the last tax reform in 1986 triggered a one-year decline in giving trends before they were restored to their prior trajectory.

Giving USA's research further shows that the amount of giving by Americans has less to do with taxes or political uncertainty and more to do with large-scale economic factors. As a leader in local philanthropy, the CNY Community Foundation affirms that our region is consistent with national trends. While tax implications matter to some degree, they are not the main driver of giving in our community.

Today, like in 1986, much remains the same after tax reform; projections are that giving will decline in the near term as a result of the change in tax incentives, but will likely rebound. For the most part, charitable giving rules were unaffected in the new law and additional planning opportunities have resulted from the changes that were enacted. Just like back then, it's important to be aware of what tax advantages exist and to align your clients' giving for maximum benefit.

So, what does this mean for you? Here's a new opportunity to help maximize your clients' giving, as well as an overview of what hasn't changed.

What Hasn't Changed

Charitable gifts made to qualified nonprofit organizations are still eligible for deduction by taxpayers. Concerns arose among charities because the law increased the standard deduction that all taxpayers could use. If your clients don't itemize their deductions, the tax benefit of charitable giving is eliminated. But the gifts themselves are still eligible for deduction, and with proper planning that benefit can still be enjoyed.

New Planning Opportunity

The increased Standard Deduction and \$10,000 cap on state and local income and property tax deductions will result in a significant reduction in the number of people who can itemize deductions. However, one of these deductions that can be adjusted is the charitable deduction. By using a donor-advised fund, your clients may be able to maximize the tax advantages of giving.

Here is how it works:

- Open a Fund. Creating a donor-advised fund at the Community Foundation is simple, there is no setup fee.
- •Make a Contribution; Get a Tax Benefit. Make a gift in the current year ("Gift Year") to the Fund that is equal to their projected charitable giving over the next several years. This amount should be large enough to allow their total deductions to exceed the standard deduction for this Gift Year.
- <u>Use the Fund.</u> Support the causes your clients care about in Central New York and beyond by recommending grants to the charities of their choice in any year they choose.
- •Add more money to the fund when it makes sense. Add to the fund when their giving depletes it, or in a year that they are able to itemize deductions.

Many other techniques still work, too.

Giving Appreciated Assets: Stock gifts provide an opportunity to reduce the 'cost' of your clients' charitable gifts. The benefit of giving cash to a charity is the tax savings resulting from the possible tax deduction, assuming that they can itemize. By giving appreciated securities to a charity, like Amazon or Apple stock, they not only get the possible tax deduction at fair market value, but also avoid paying capital gains tax on the appreciation. This eliminates the 15% to 32% combined federal and state tax (depending on their income) on the appreciation. Two additional ways to use gifts of appreciated assets are:

•Resetting Cost Basis: Once an appreciated security is gifted, the same security can be repurchased in the future, thus resetting the cost basis to the current fair market value.

•Rebalancing a Portfolio: When rebalancing a stock allocation, some portion of this rebalancing may be achieved by donating appreciated securities and then using cash to buy the assets that need to be increased within the allocation.

Required Minimum Distributions (RMDs): Your clients can donate an amount to generate a charitable deduction that offsets the additional taxable income.

Charitable IRA Rollover: There is also a way to transfer a gift from an IRA to charity without it being counted as income or being taxed. This is called a qualified charitable distribution (QCD), more commonly known as the Charitable IRA Rollover. In addition to being a tax-free rollover, the QCD can count toward your clients' required minimum distributions in any given tax year if completed by 12/31. If they don't itemize, the QCD is an attractive alternative gift structure, especially for individuals looking to sustain or even increase giving as their cashflow changes in retirement.

Giving Other Assets: Your clients can still use assets other than cash or publicly traded securities to fund their charitable giving. The Community Foundation can also accept closely held shares, LLP or LLC interests, real estate, commodities (e.g., silver bars), life insurance and most any other asset that has value. Some of these asset types take more planning and effort and can't be implemented quickly, but allow them to use any of their assets for giving.

<u>Legacy Gifts:</u> Any bequest, beneficiary designation, or gift from an estate still works under the new tax law.
