



Letter from the **PRESIDENT**

Hon. James C. Tormey, III

The legal community suffered a significant loss in the passing of Hon. James C. Tormey, III this past June 22, 2019. Judge Tormey served 32 years on the bench, and as Administrative Judge - Fifth Judicial District since 2000 where he supervised some 300 judges. Some of his many accomplishments as Administrative Judge include: peer review and mentoring programs for judges; centralized arraignment parts in the Fifth Judicial District; pro bono and access to justice initiatives; and yearly educational conferences for judges. He also established Drug Courts; Opioid Courts; Human Trafficking Court; Youthful Offender Court and Community Court.

In the New York Law Journal, Chief Administrative Judge Lawrence Marks said, "Jim Tormey was a hardworking, highly effective administrative judge for many years.....his passing is a major loss for the state court system and for all those committed to the cause of justice." County Court Justice Hon. Stephen J. Dougherty said, "Judge Tormey supervised the implementation and was totally supportive of court innovations, from Drug Court to Domestic Violence Court to Adolescent Diversion Court to Human Trafficking Court. He considered 'problem solving courts' to be integral to address today's societal issues." Judge Tormey's good friend and Supreme Court Justice Hon. Gerald Neri said the Judge lived by two quotes - "Temper justice with mercy" and "Justice delayed is justice denied." Judge Neri went on to say Judge Tormey was the first to credit his fellow judges, employees and staff for the district's success. Hon. David S. Gideon worked with Judge Tormey as court attorney referee and special counsel for town and village courts in the Fifth Judicial District. Judge Gideon said, "The district and bar community lost a great jurist and wonderful human being. He was a great friend, mentor, colleague and boss." Hon. Anthony LaValle is the principal law clerk and special counsel for the Fifth Judicial District. He added, "I learned two things from Judge Tormey in my short tenure - life is about relationships and one should always take care of one's co-workers and staff. Judge Tormey was the best at both." All agreed that Judge Tormey always had their back.



Attorney Jim Reid knew Judge Tormey from their law school days at Syracuse University. He said, "Judge Tormey was always so upbeat, and everything to him was always the best. He had an unbelievable memory. He would meet you once and never forget you."

Judge Tormey was a fellow parishioner and lector at Most Holy Rosary Church and part of our 8:00 a.m. mass 'family'. Often before mass, he could be seen moving from pew to pew greeting the parishioners, and always referring to himself as 'Jim'. Above all, Judge Tormey was totally devoted to his family and friends. Simply put, he loved people and helping people. He will be missed.

More than 100 guests celebrated six attorneys who reached the milestone of practicing law for 50 years at the Bar Foundation's 50-Year Luncheon on June 13 at Drumlins. The honorees were: Richard B. Alderman, Michael J. Balanoff, Thomas J. Kellish, Elizabeth C. McGinty, Andrew A. Mecca and Samuel M. Tamburo. Three members not in attendance were also recognized: Arthur A. Chalenski, Ronald A. Mittleman and Joseph C. Watt, Jr.

RICHARD B. ALDERMAN

Dick Alderman received his law degree from the University of Pennsylvania Law School, joined the United States Army Reserves and headed to Fort Dix for basic training in 1969. On Christmas leave that year he was sworn in to practice in New York State by Judge Frank Delvecchio.

He began his law practice with Alderman, Alderman, Samuels and Schepp, under the tutelage of his father, brother, and Bernie Samuels. Remembering the lessons taught them by their father, a founder in 1922 of what is now the Alderman and Alderman law firm, the practice focuses on Family and Matrimonial Law.

Dick wrote: "For me there is nothing better than representing clients who are dealing with serious personal issues such as custody of children, spousal or child support, or equitable distribution of marital property...I have no interest in retiring."

MICHAEL J. BALANOFF

Michael Balanoff attended Tufts University as a member of the Class of 1964. He remained there to graduate from the Boston College Law School where he was Editor of the Law Review.

Mike joined the U.S. Army in 1968 and, while in Vietnam, his military service was made illustrious as a Bronze Star Medal recipient – a distinction given to those soldiers who commit heroic or meritorious acts during active combat.

Upon his return to the states, Mike's primary areas of practice were commercial law, debtor and creditor rights, business acquisitions and bankruptcy. In 1972, he began with Grass & Balanoff where he practiced until 1996. From 1996 to 1998 he was with Costello, Cooney & Fearon, and from 1998 to 2014 was with Bousquet Holstein (formerly known as Green & Seifter).

From October 2014 to October 2017 he was Legal Services of Central New York's Director of Development and is currently the President and CEO of the Jewish Federation of Central New York and Executive Director of the Jewish Community Foundation of Central New York.

THOMAS J. KELLISH

Tom Kellish was born on a dairy farm in Pompey/Lafayette. He earned his B.S. from Cornell in 1963 where he also served in ROTC. Following a two-year tour of duty with the U.S. Army Medical Service Corps, he earned his J.D. in 1968 from the University of Tulsa, Oklahoma.

Tom returned to New York where he worked for the Kenyon & Ames law firm in Tully until opening his own law office in 1972, with a branch office in DeRuyter. He was admitted to practice before the U.S. District Courts for the Northern District of New York and Oklahoma.

"Life is good," Tom says and he acknowledges many friends, neighbors, family members and professional colleagues – both past and present – for their advice, camaraderie, and close working relationships over 50 years.

ANDREW A. MECCA

Andy Mecca was born and raised in Solvay, where he attended Solvay High School. He enlisted in the United States Air Force. In 1955, he was transferred to the 29th Air Division Strategic Air Command in Montana. In the Air Force, Andy became a boxing coach and entered the Golden Gloves State of Montana.

Andy was honorably discharged from the military in 1958 and, using the military bill, attended Syracuse University and the University of California Law School. After his admission to the New York State Bar, Andy joined the John Shaffer Law Office where he honed his trial skills. In 1969, he was elected Camillus Town Board Councilman, 4th Ward and served with Supervisor of the Town of Camillus, fellow honoree Sam Tamburo. Thereafter, he was elected Town Justice of Camillus and continued to serve in that capacity until 1990.

SAMUEL M. TAMBURO

Sam Tamburo is a native of Auburn who graduated from the Harpur College of Arts & Sciences at SUNY Binghamton and received his J.D. from the University at Buffalo School of Law.

Under the auspices of the noteworthy expertise of George W. Cregg, Sr., Sam entered into the practice of Municipal Law. He has considered it an honor to practice alongside Andrew Pappas, Martin and Beverly Michaels, William Regensberger, Richard Priest, Hugh C. Gregg III, and Gene and Jim Tarolli.

Sam was twice elected to the Town Board of Camillus in the 1970s and again in the 80s. He enjoys practicing law on an as-needed basis from his Cayuga County home.

ELIZABETH C. McGINTY

Liz was born in Brooklyn and in 1963, graduated from Notre Dame of Maryland University, with a Bachelors in History and minors in English and Philosophy. She then attended St. John's University School of Law: of the five women who started with her in the class of 168 students, she was the only one who finished!

Liz passed the Bar in 1968 and was admitted to practice in the 2nd Department. Shortly after, she and husband Jim – honored at last year's 50-Year Luncheon — moved to Syracuse and she spent the next 12 years as a "housewife." In 1983, she was hired by Davoli, McMahon & Kublick, doing real estate closings. After two months, she was thrown into litigation and became the first woman partner at that firm in 1989. The firm changed its name to McMahon, Kublick, McGinty & Smith in 1995, and Liz focused on litigation – first defense, then plaintiff's including personal injury, product liability, medical malpractice and construction accidents.

She represented the towns of Cicero, Salina and Van Buren, and the Village of North Syracuse, in zoning and planning matters.















This June marked the 50th Anniversary of the violent police raid of The Stonewall Inn, a Greenwich Village pub favored by local lesbian, gay, and transgender people.

We're proud in June of how far from the 1969 Stonewall Riots our LGBTQIA+ colleagues, business partners, military members, neighbors, siblings, relatives, and the list goes on and on, have come since the days when the flame of their sexuality and gender identity would no longer be dimmed by an unenlightened society.

Following the tumult of the Civil Rights Era the fight for LGBTQIA Rights was outed in the aftermath of Stonewall. The social uprising incited social and political activism that in the five decades since the raid has netted the community a painstaking progression toward equality.

Throughout the month and across the country celebrations were conspicuous and plentiful in parades, community meet-ups, and rallies.

And on Monday, June 10th Onondaga County Bar Association members were hosted by the OCBA Diversity & Inclusion Committee in the gracious offices of Barclay Damon for an after-work networking reception.

Among the guests was Matthew Skinner, the executive director of the Richard C. Failla LGBTQ Commission of the New York Courts. On a tour to "try to hit every corner of the state," Skinner stopped in Syracuse to

attend the event, before going to others like it in Monroe and Erie counties.

"Fifty years from now, I hope we have a society where we are all fully equal under the law and don't have to worry about what is 'normal' and expected," he said.

"And that all the firsts will be over."

The Commission, which the OCBA recognized with the 2018 Diversity & Inclusion Achievement Award, promotes awareness of LGBTQIA+ issues within the court system by respecting the dignity of all who cross a courthouse threshold.

This year, the Commission's key initiative is to assure transgender people are completely welcomed in the court system. Thanks to the Gender Expression Non-Discrimination Act, signed into law in January 2019, signs are now posted outside the state's hundreds of courthouse restrooms that assure no one is denied access based on their gender identity or expression.

At 401 Montgomery Street, the signs are visible throughout the court house. Building employees remark the change has been easily accepted.

"It's like you're at home," said Karen Wilcox, secretary to Syracuse City Judge Mary Anne Doherty, a Failla Commission member. "We all have to use the restroom."

Transgender Name Changes and More

Syracuse celebrates another win for the LGBTQIA+ community in the recent establishment of an LGBT* Rights Attorney position at the Volunteer Lawyers Project of Onondaga County, Inc.

A longtime friend to VLP, Mallory Livingston began working in the role in May.

Through a NYS Department of Health five-year grant, Executive Director Sally Curran says a "recognized huge community need" can be satisfied by Livingston's work in facilitating transgender name changes, amending identity markers, and addressing larger discrimination and access to health care issues.

She just needs help to do it.

"Word is getting out" about the program that is becoming inundated with requests from the fivecounty region VLP typically serves, said Curran. Now, they've represented people in name changes in 27 counties.

Last year, VLP received roughly 75 name change requests. Altogether VLP has handled 266 name changes since 2013; 167 are currently closed and 47 are pending. All of them 100 percent successful.

"But I got five requests yesterday," Livingston noted.

Curran said she anticipates receiving 200 more requests before year end.

"We're in desperate need for lawyers and paralegals to help out with name changes, or with expertise in ERISA, healthcare, and insurance," she said. "And critically we want to train lawyers to help."

VLP found that partnering with area doctors' offices provides an inroad to bring legal resources to those experiencing harassment and discriminatory actions by insurance carriers, or in the workplace, in public accommodation, and elsewhere.

"The trans population is very isolated socially, and it's hard to communicate to and reach them and we find that sooner or later they'll end up at a (medical) clinic," Livingston said. "Through the process we find out about other problems."

Once referred to VLP, transgender clients often divulge their stories and what came in as a straightforward name change can become a multi-faceted attorneyclient relationship with access to a variety of legal services.

But name changes, while appearing simple, can be fraught with danger.

Through advocacy, VLP is able to get the publication of name change notices waived, thus avoiding being outed publicly as transgender and potentially targeted for discrimination, harassment or even violence. And for low-income clients, the \$210 filing fee is also waived.

A name change may seem like a small legal transaction that folks might try to affect themselves, but the forms and the process are confusing and most people give up in frustration, Livingston said.

"You'll not find a happier client than when you tell a transgender client their name change went through," she said.

"You get hugs, you get tears. Because it's the first time in their life they receive official validation of who they are."

THE PRACTICE PAGE:

NEW STATUTE OF LIMITATIONS FOR SEX ABUSE

Effective February 14, 2019, New York changed its statute of limitations for cases that may be brought by victims of various forms of sexual abuse. The New York Child Victims Act amends provisions of CPLR Article 2 and corresponding provisions of the Criminal Procedure Law, General Municipal Law, and Judiciary Law. The public policy behind the Act is the recognition that the nature and secretiveness of sex abuse against minors interferes with the minors' short and long-term abilities to seek legal redress within the standard infancy toll of CPLR 208.

On the criminal side of the equation, CPL 30.10 was amended to provide that criminal statutes of limitations are tolled for victims under the age of 18 at the time of the abusive act(s), until the victim turns 23. This applies to any conduct violative of Penal Law Article 130 (various defined offenses such as sexual misconduct, sexual abuse, aggravated sexual abuse, and rape in various degrees), sections 255.25, 255.26, and 255.27 (incest in the first, second, and third degrees), and section 263.05 (use of a child in a sexual performance).

Civilly, CPLR 208 is amended to provide, in new subparagraph (b), that for minors victimized by any of the foregoing sex offenses defined by the Penal Law, actions may be commenced for damages from physical, psychological, or other injuries or conditions, until the victim plaintiff reaches the age of 55. It matters not whether the causes of action are based on negligence, intentional tort, or both. For decades, the infancy toll of the statute of limitations has been to age 18, and for any applicable limitations periods of more than three years, those limitations were capped at three years by CPLR 208. As a result, when tolls are needed to extend the time for commencing actions, infant plaintiffs could never timely commence actions beyond, at most, age 21. These standard tolling provisions, including the post-toll three-year cap for limitations periods greater than three years, still apply to all other actions in what is now denominated in new subparagraph (a) of CPLR section 208; but the standard tolling provisions no longer apply to the defined category of sexual abuse torts, where actions may now be brought to age 55. The durational difference is significant.

A new CPLR 214-g has also been enacted. It provides that if the plaintiff or infant plaintiff seeks to commence an action based on prohibited sexual conduct against a municipality, the state, or a school district, the requirement of GML section 50-e(1)(a), that there be service of a notice of claim within 90 days of the accrual, no longer applies. The elimination of the notice of claim requirement makes sense given the nature of the surreptitious conduct that these actions involve, and the intent of the legislature to enable plaintiff victims to bring civil actions for many additional years, even decades. CPLR 214-g also provides from its effective date a one year revival period for qualifying cases which were already time-barred or dismissed, no matter how long ago the alleged sex abuse occurred. Section 219-d has been added to the Judiciary Law authorizing the state's Chief Administrative Judge to promulgate rules for the timely adjudication of revived actions, which might hint at trial preferences. The unique and sensitive nature of these cases also is recognized by the addition of section 219-c to the Judiciary Law, which directs that there be specialized training of judges and justices for sexual abuse and sexual assault cases. Presumably, the language applies to jurists in both criminal and civil Parts.

These statutory amendments suggest that the legislature will not permit individuals or institutions to benefit from traditional statutes of limitations, at the expense of minors, by "running out the clock" on victims who have been, or are, too afraid, ashamed, or damaged to seek remedies in the courts against those who have allegedly preyed upon their vulnerabilities. Predictably, new civil actions may be commenced courtesy of this new law.

NOTICE: FOR REAPPOINTMENT OF INCUMBENT MAGISTRATE JUDGE

The current term of the office of United States Magistrate Judge Therese Wiley Dancks at Syracuse, New York is due to expire on February 9, 2020. The United States District Court is required by law to establish a panel of citizens to consider the reappointment of the magistrate judge to a new eightyear term.

The duties of a magistrate judge position in this court include the following:

(1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemea nor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from the judges of the district court; (4) preparation of report and recommendations to the judges of the district court on prisoner civil rights cases, habeas corpus



cases, social security appeal cases and other civil matters as referred by the judges of the district court; and (5) trial and disposition of civil cases upon consent of the litigants.

Comments from members of the bar and the public are invited as to whether the incumbent magistrate judge should be recommended by the panel for reappointment by the court and should be directed to the attention of the Committee Chair; in care of: John M. City of Syracuse Aligns Omitted Tax Billing with Other Municipalities

The City of Syracuse is changing the way is handles billing for omitted taxes. Starting July 1st, the City will no longer issue supplemental tax bills for the additional taxes owed.

Instead, the City will handle the additional, prorated taxes, known as "omitted taxes," the same way they are treated in most other cities and towns in New York: the omitted taxes will be billed on the following year's tax bill. Omitted taxes will be identified as a separate levy line item on the City-School and County tax bills. Since the City is adopting a practice that has long been used in most other municipalities, the practice should be easier for lenders, brokers, attorneys and others in the real estate community.

Regarding the billed amount to property owners, for the rest of the City-School and County tax bill periods the new owner pays the

same reduced amount as the prior owner. The next tax bill (the first full year bill) will be higher than normal because it doesn't have the exemption AND it has the omitted taxes from the prior year on it. The following year (the second full year tax bill) and thereafter, will be the true amount.

The Onondaga County Bar Association (OCBA) is seeking nominations for the 2019 Distinguished Lawyer. We have been honoring a local attorney for distinguished service to the profession since 1968. The Distinguished Lawyer Committee reviews written nominations and recommends a candidate to the OCBA Board of Directors for its approval.

In order to qualify for nomination, the lawyer

- (1) must have devoted a professional career to the law;
- (2) must possess exceptional lawyering skills;
- (3) must display a devotion or dedication to the profession as evidenced by involvement or participation in projects or activities, reflecting an unselfish donation of time to the betterment of the profession; and
- (4) must possess ethics beyond reproach.

The Distinguished Lawyer Committee is also accepting nominations for the William C. Ruger Centennial Award, created during the OCBA Centennial in 1975. The Ruger Award was named after the first president of the OCBA, who later served as Chief Judge of the New York State Court of Appeals. This award is given to a judicial officer and is "reserved for recognition of singularly outstanding achievement in devotion to the principles of our system of justice." Since the creation of this award, only 10 jurists have been its recipient.

This year we are expanding our search for nominations and hope that you can help us. There is no specific form for nominations. Simply send a letter, including the name of the attorney or jurist, a resumé, and a description of why the individual meets the above criteria for either The Distinguished Lawyer or Ruger Award. Feel free to include any supporting information that may be helpful to the Committee.
