We Remember Rosalind W. Johnson, Esq.

Longtime Onondaga County Bar Association member the Hon. Langston McKinney stopped by the OCBA office recently to let us know that his former colleague Rosalind W. Johnson had passed away in August.

At the time of her death, Ms. Johnson was an established lawyer in Columbia, Maryland. But early in her legal career, she practiced in Syracuse, which was how she came to know and earn the esteem of Judge McKinney.

Then, according to the judge, Ms. Johnson was among a group of female black attorneys whose legal talents "paved the way" for others to pursue a career in the law. She worked tirelessly, he said, on behalf of the then-named Onondaga Neighborhood Legal Services, which we now know as Legal Services of Central New York, Inc.



Parts of her obituary are excerpted here.

Rosalind W. Johnson was born Rosalind Kay Williams in Miami, FL on September 24, 1939. As a child, Roz was known as a smart, fearless leader who read countless books, day and night, in a room she shared with her little sister. Roz loved reading, history, and escaping into mystery series' like "Nancy Drew" and "The Hardy Boys." Literature developed her imagination during her sheltered upbringing in segregated Miami.

Not much changed by the time Roz was walking the halls of Northwestern Senior high School. She was still smart and cute, her sister June remembers, and adored by her teachers. When she wasn't in class, Roz often spent her time dancing and twirling batons as a majorette for her high school football team. She graduated with honors in 1957 among the top three percent of her class.

When the opportunity came to discover life outside of Miami, Roz was ready. After high school, she attended Talladega College, an historically Black college in Talladega, Alabama. There, she majored in history and joined the Alpha Kappa Alpha Sorority, where she formed many close friendships and had remained an active member throughout her life. Roz also participated in other campus organizations like the debating society, which sharpened her debating skills for what would become a lifelong career in law.

After graduating from Talladega, she moved Chicago and briefly worked as a school teacher. While there, romance was blossoming in Roz's life. She and J. Kenneth Johnson Jr. married and moved to Washington DC. During those early years, Rosalind attained a master's degree in counseling and graduated from the Howard University School of Law. She graduated with her Juris Doctor from Howard in 1969.

Following a stint as an attorney at a law firm in Syracuse, Roz and her family moved to Columbia, Maryland, where she continued to live for five decades. As a lawyer, Roz had held many different and interesting positions. First as an attorney for the federal Equal Employment Opportunity Commission, and then as the United States Department of Justice, where she litigated and acquisition cases for more than 10 years.

But her favorite job, perhaps ever, was representing kids and teens in the foster care system at the Counsel for Child Abuse and Neglect (CCAN) in Washington DC. Her daughter Wendy recalls that Roz was so good with teenagers that judges kept assigning her teens, many of which had experienced intense rejection and disappointment.

For Roz, the role wasn't just a 9-to-5 job. She loved the kids and gave them Christmas gifts, Easter baskets, clothes, school supplies and plenty of straightforward advice. She didn't stop there. Roz even came to visit them for proms, graduations, birthday parties and other milestones. She continued to keep up with them throughout their young lives, even after they aged out of the foster care system.

Roz continued to grow spiritually within the fellowship of a community Bible study for more than 30 years. She helped facilitate their meetings through phone calls and emails, letting the others know exactly what was going on and each others' prayer requests.

Her love for literature also didn't cease, and the girl who loved to read became the woman who loved to write. Towards the end of her legal career, Roz took up a passion for prose. She spent countless hours working on her first book, "Friends to Die For," which told the story of six friends who came of age at the eve of the civil rights movement.

Roz followed up with "Secret Lives" and "Roz' Little Manual for Surviving Potholes." Her last published book, "T.J. Sloane," was her first novel featuring a male protagonist. She was working on "Roz' Little Manual for Writers" when she was diagnosed with pancreatic cancer in November 2022.

Roz passed away peacefully at Johns Hopkins Howard County Medical Center on August 6, 2023 surrounded by her family and close friends. She was 83 years young.

Roz was predeceased by her parents, Elsie and Earl Williams Sr., her brother Earl Williams Jr., Esq., her son James Kenneth Johnson III and her former husband J. Kenneth Johnson Jr. DDS.

Mentorships to date have paired experienced attorneys with those seeking assistance with law office management, organization, record keeping and the appropriate use of IOLA accounts.

The Mentorship Program benefits from our OCBA members willing to help others succeed by sharing their vast substantive knowledge, experience and time with other attorneys. Mentors are available to assist in varying areas of the law - a criminal attorney who has only handled misdemeanor cases may benefit from a relationship with a Mentor as they wish to grow their practice to include felony matters, a lawyer who has handled family court matters can be supported by a Mentor as they establish a practice representing clients in Supreme Court divorce matters or a lawyer who represents small businesses may wish the guidance of an experienced attorney as the clientele and practice both flourish. The program not only improves the quality of our Bar, but strengthens the relationships among our members.

Both the participation of the Mentor and Mentee are voluntary and confidential; the formal program is for a period of one year and the participants agree to meet on at least a bi monthly basis. However, in most circumstances, the Mentor is available for informal contact and guidance as well.

New York lawyers faced with ethical questions regarding their own prospective conduct can reach the Ethics Hotline by calling volunteers Victor Hershdorfer at **315-913-4087** or Tony Gigliotti **315-727-6780**.

The Ethics Hotline is operated and staffed by members of the Onondaga County Bar Association's Committee on Professional Ethics (the "Committee"). These volunteers respond to inquiries made by lawyers admitted in New York who face ethical questions regarding their own prospective conduct. The purpose of the Hotline is to provide informal guidance to callers in accordance with the New York Rules of Professional Conduct (the "New York Rules"). Any information provided in response to a Hotline inquiry is merely the opinion of the Committee member answering the call. It is not the opinion of the Committee as a whole. The information provided in response to a Hotline inquiry does not constitute legal advice. If the matter involves complex issues, or implicates a substantive area of law, you may wish to retain professional ethics counsel.

Callers should be aware of the following guidelines before calling the Ethics Hotline:

- 1. The Hotline only provides guidance to lawyers admitted to practice in New York about the New York Rules.
- The Hotline only provides guidance concerning the caller's own prospective conduct. We do not answer questions about past conduct or the conduct of other lawyers.
- 3. The Hotline does not provide legal advice or answer questions of law.
- 4. The Hotline does not provide answers to hypothetical questions nor inquiries which have also been submitted to another bar association's ethics committee.
- 5. The Hotline does not answer questions about the unlicensed practice of law (UPL). UPL is governed by statutory law, not the New York Rules and is, therefore, outside the Committee's jurisdiction.
- 6. The Hotline provides general guidance. Due to the limited information we can obtain during a brief and informal telephone conversation, we cannot provide a definitive answer to Hotline questions.
- 7. The Hotline does not answer questions where the issue itself is the matter of a pending legal proceeding or is before a grievance committee.
- 8. Although it is the Committee's policy to maintain confidentiality of all Hotline inquiries, callers should be aware that the information is not protected by the attorney-client privilege or RPC 1.6.
- 9. The Ethics Hotline does not respond to complaints or inquiries regarding unethical conduct of other lawyers. Any such complaints or inquiries should be addressed to the Grievance or Disciplinary Committee for the county in which the lawyer practices (see http://www.nycourts.gov/attorneys/grievance/).
- 10. Lawyers who call the Ethics Hotline are required to provide their full name and telephone numbers.

If, after speaking with someone on the Hotline, a New York lawyer wishes to obtain a written Informal Opinion from the Committee, he or she may submit a written request. Please review the guidelines for requesting an Informal Opinion here (See attached guidelines – need hyperlink to the document). As with Hotline questions, the Committee's Informal Opinions are limited to interpreting the New York Rules. Please be aware that the Committee cannot provide a concrete timeline for responding to written requests. If your matter is urgent, you may wish to retain professional ethics counsel.
